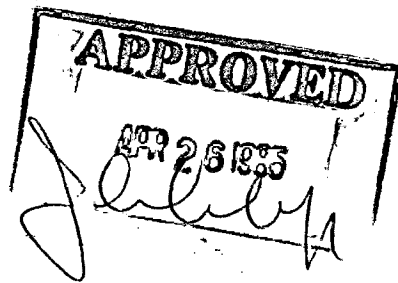
NOW, THEREFORE, BE IT RESOLVED, That the City Council of the City of Providence hereby endorses House Bill 85-H 5202.

RELATING TO THE BUREAU OF LICENSES  
OF THE CITY OF PROVIDENCE

It is enacted by the General Assembly as follows:

- 1 SECTION 1. Chapter 45-2 of the General Laws entitled "Gen-  
2 eral Powers" is hereby amended by adding thereto the following  
3 section:  
4 45-2-23. City of Providence - Bureau of licenses. -- Not-  
5 withstanding the provisions of section 45-6-2 of the general laws  
6 or any other general or special law to the contrary, the bureau  
7 of licenses of the city of Providence is hereby authorized to  
8 impose a fine not to exceed five hundred (\$500) dollars upon any  
9 person, firm or corporation which holds a license issued by said  
10 bureau for the violation of any statute, ordinance, condition,  
11 rule or regulation applicable to the license.

SECTION 2. This act shall take effect upon passage.
