CHAPTER 1983-30 APPROVED JULY 10, 1983 BY TRANSFERRING VARIOUS
SUMS OF MONEY WITHIN VARIOUS DEPARTMENTS, AS AMENDED.

Be it ordained by the City of Providence:

SECTION 1. Chapter 1983-30 of the Ordinances of the City of Providence, as approved July 10, 1983, entitled: "An Ordinance making appropriation of One Hundred Sixty-Nine Million, Seven Hundred Ninety Six Thousand, Two Hundred Forty Dollars and Ninety-Six Cents (\$169,796,240.96) For the Fiscal Year ending June 30, 1983, as amended", is hereby further amended by transferring various sums of money within various departments. 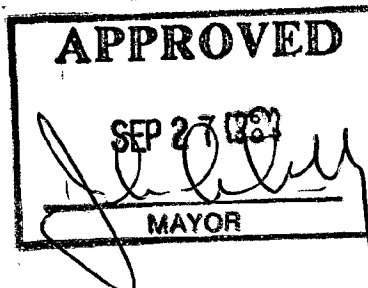
