




Thank you, also, for your offer of a donation. I will be in touch as soon as we know what money we have and what we need.

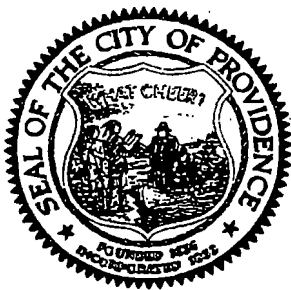
