CITY COUNCIL RESOLUTION

Our response to your letter of August 30, 1978 has been delayed since we needed to consult with our Regional Office. Public Protection Grading in Rhode Island is currently a responsibility of our Regional Office.

Our investigation and evaluation of public fire protection facilities is undertaken for insurance ratemaking purposes only. Therefore, we do not undertake "an investigation of the condition of firefighting equipment of the fire department" unless it is part of a complete survey of all fire protection facilities. In addition to the apparatus we would have to investigate the fire department in depth, including a review of records and other factors. Also, we would need to make an in-depth study of the water supply and distribution system of the city, fire safety communications and fire safety control. The latter item includes a review of building laws, electrical codes, special hazards, storage of compressed gasses and flammable liquids.

This study in a city the size of Providence takes a substantial amount of field work and analysis stretching over a period of perhaps months. Completion of the review results in the development of a grading which may affect changes in all fire insurance rates in the city. We do not charge for our analysis and a report is given to the Mayor when completed. However, it would probably be late in 1979 before we could begin such a study because of backlog of other municipalities requiring grading service.

If there is any urgency at all in this request, we would suggest that you turn the project over to a consulting engineering firm which might be in a position to give you a more timely response.
