No. 376 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE
CHAPTER 1986-30 APPROVED JUNE 26, 1986, BY TRANSFERRING VARIOUS
SUMS OF MONEY WITHIN VARIOUS DEPARTMENTS, AS AMENDED.

Be it ordained by the City of Providence:

SECTION 1. Chapter 1986-30 of the Ordinances of the City of Providence, as
approved June 26, 1986, entitled: "An Ordinance making appropriation of One Hundred
Eighty-eight Million, Two Hundred Nine Thousand, Twenty-four Dollars and Seventy-
