





RESOLVED THAT His Honor the Mayor be and he hereby is authorized to execute a lease to Ace Warehouse Co. of R. I., a Rhode Island corporation, of land and buildings at Fields Point, Providence, R. I., including ninety thousand (90,000) sq. ft. of space in the southwesterly portion of Building No. 3, indicated as "Storage Building Area Shaded Red 90,000 sq. ft." on "Providence, R.I., City Engineer's Office City Property Dept., January 21, 1948, No. 059773", attached hereto as Appendix A, and 29,475 sq. ft. of additional land for parking and loading area and shared use of the railroad siding, indicated as "Shaded Area Proposed Additional Lease 29,475 sq. ft." on "Proposed addition to A & P Lease at Fields Point, Dated June 2, 1959, No. 061887", attached hereto as Appendix B, formerly occupied by The Great Atlantic and Pacific Tea Company, Inc., the new lease to be for ten (10) years, at an annual rental of FORTY-ONE THOUSAND FIFTY-EIGHT (\$41,058) DOLLARS; the lease to have an option to renew for an additional five (5) year period. The rental for the option period shall be subject to agreement between the parties.

The lease shall contain further terms and conditions as may be approved by His Honor the Mayor and the City Solicitor.
