Resolution Honoring Saint Patrick's Day.

WHEREAS, The celebration of the Saint Patrick's Day in the United States has a long history dating back to the City of Boston hosting its first Saint Patrick's Day Parade as early as 1737; and

WHEREAS, The first celebration in Providence of the festival of Saint Patrick was held on March 18, 1839; and

WHEREAS, Irish immigrants living in the United States began organizing parades and other events on March 17 as a show of pride in their heritage; and

WHEREAS, According to the 2020 Census data, Rhode Island has 17.6% of its population claiming Irish ancestry which is the third highest percentage in the entire country; and

WHEREAS, The Providence Saint Patrick's Day Parade Committee will be hosting their 2022 parade on Saturday, March 19th, which will be the 29th straight year it has been hosted in Providence; and

WHEREAS, The City Council of the City of Providence takes this day to recognize the contributions and influence of Irish Americans to the history, culture, and achievements of the country as a whole, the State of Rhode Island, and the City of Providence.

NOW, THEREFORE, BE IT RESOLVED, That the Providence City Council hereby acknowledges March 17 as Saint Patrick's Day in perpetuity in order to celebrate Irish heritage and to recognize the contributions that the Irish people have made to the City of Providence and the State of Rhode Island throughout our history.

Resolution Acknowledging March 19th as Saint Joseph's Day.

WHEREAS, Saint Joseph's Day, also known as the Feast of Saint Joseph or the Solemnity of Saint Joseph, is in Western Christianity the principal feast day Joseph of Nazareth, husband of the Virgin Mary and earthly father of Jesus Christ; and

WHEREAS, Since the 10th century, March 19th has been the traditional day of celebration. Popular customs include attending mass, wearing red-colored clothing, and partaking in the Zeppole, a traditional Italian pastry made up of fried dough, and filled with custard or pastry cream; and

WHEREAS, Saint Joseph's Day is an integral celebration within the Catholic Church especially in Italy, where traditions date back to the Roman Empire; and

WHEREAS, Providence is currently home to thousands of proud Italian-Americans, with 14 percent of the population claiming Italian ancestry. Italians have a long and rich history in Providence, with more than 5 million immigrants arriving in the city between 1820 and 2000. In the early 1900s, the Federal Hill neighborhood became one of the most densely populated and largest Italian settlements in the nation; and

WHEREAS, At the turn of the century, Atwells Avenue became the center of business and culture for the city's Italian population and widely became known as Rhode Island's own "Little Italy." While the area today is more diverse, Federal Hill still retains its status as the traditional center for the city's Italian-American community. Providence's annual Columbus Day parade marches down Atwells Avenue; and

WHEREAS, The strength and success of the City of Providence, the vitality of our neighborhoods, and the effectiveness of our American society depend, in great measure, upon the distinctive and sterling qualities demonstrated and exemplified by members of the Italian and Italian-American community, who share with us their rich and unique heritage.

NOW, THEREFORE, BE IT RESOLVED, That the Providence City Council recognizes March 19th, as Saint Joseph's Day in perpetuity, a sacred and valued part of Italian culture, and an illustrious tradition for the thousands of Italian Americans who call Rhode Island home.

Resolution Celebrating the Life and Legacy of Former Providence Solicitor Charles R. Mansolillo, Esquire.

WHEREAS, On Monday, March 7, 2022, former Providence City Solicitor Charles R. Mansolillo, Esquire passed away at age 72; and

WHEREAS, Mr. Mansolillo was born in Providence on March 8, 1949, and was the eldest son of the late Nicholas W. and Adeline A. (Marcello) Mansolillo; and

WHEREAS, Mr. Mansolillo was a 1967 graduate of Classical High School and a 1971 cum laude graduate of Saint Michael's College. In 1985, he received his law degree from Suffolk Law School and was admitted to the Rhode Island Bar Association; and

WHEREAS, In 1973, Mr. Mansolillo began his career in Rhode Island state and local government as the youngest member of the Providence delegation in the General Assembly; and

WHEREAS, In 1975 he served as a Councilman and subsequently as Chief of Staff to Mayor Vincent A. Cianci, Jr; and as a member of the Commission that authored the Providence Home Rule Charter; and

WHEREAS, In 1986, Mr. Mansolillo was the Republican nominee for Mayor of Providence. He returned to state government in 1987 as legal counsel in the Department of Children and Their Families. Subsequently, he was appointed Director of the Governor's Office of Housing, Energy, and Intergovernmental Relations by Governor DiPrete, and later as the Governor's Policy Director; and

WHEREAS, In 1991, Mr. Mansolillo rejoined Providence city government as Deputy City Solicitor, and thereafter in 1992 was appointed City Solicitor by Mayor Cianci. In 2003, the Providence City Council conferred upon him the honorific title of City Solicitor Emeritus; and

WHEREAS, Active in community affairs Mr. Mansolillo served as Chairman of the Board of Directors of the Providence anti-poverty agency ProCAP, Inc., and as a trustee of the Providence Public Library. He also served as chairman of the board of the Providence Catholic Schools Collaborative; and

WHEREAS, Mr. Mansolillo leaves four brothers, Robert N. Mansolillo (Nancy) of Nashua, New Hampshire, John M. Mansolillo (Marlene) of North Providence, Nicholas W. Mansolillo of Orlando, Florida, and James P. Mansolillo (Lauren) of Cranston; his nieces, Marissa G. Mansolillo and Stephanie E. Peluso; and his nephews, Jared G. Mansolillo, Michael R. Martin and Andrew A. Martin.

WHEREAS, All 39 cities and towns are members of the Rhode Island League of Cities and Towns; and

WHEREAS, The Rhode Island League of Cities and Towns serves as a convener and advocates to the Governor and General Assembly to support the needs of municipalities throughout the state; and

WHEREAS, The Rhode Island League of Cities and Towns believes in:

- Supporting robust local government funding through municipal aid programs, education aid and grants
- Opposing any constraints on the ability to raise local revenue
- Opposing unfunded state mandates, particularly related to workforce management and personnel costs
- Maintaining local control and decision-making that reflects community needs, including land use, business operations, licensing, etc.
- Supporting greater flexibility for local government to innovate, improve efficiency and save tax dollars; and

WHEREAS, There has been an influx of federal aid to support the economic recovery from COVID-19 to cities and towns; and

WHEREAS, Property taxes represent approximately two-thirds of revenue for municipal budgets statewide, and Rhode Island has the eighth-highest property tax burden in the nation; and

WHEREAS, Any reduction in state funding would exacerbate that problem, ultimately leading to service reductions, layoffs and property tax increases; and

WHEREAS, The Rhode Island League of Cities and Towns conducted a survey of all 39 members to develop legislative priorities for the 2022 session of the Rhode Island General Assembly.


