AN ORDINANCE

IN AMENDMENT OF CHAPTER 1973-52

OF THE ORDINANCES OF THE CITY OF PROVIDENCE, APPROVED DECEMBER 24, 1973 ENTITLED "AN ORDINANCE APPROVING AND ADOPTING THE OFFICIAL REDEVELOPMENT PLAN FOR THE WEST BROADWAY NDP URBAN RENEWAL AREA (1)" FOR THE ACQUISITION OF PROPERTY LOCATED ON LOT 35 PLAT 52, 1577 WESTMINSTER ST.

Be it ordained by the City of Providence:

1. That Chapter 1973-52 of the Ordinances of the City of Providence approved December 24, 1973 and entitled "An Ordinance Approving and Adopting the Official Redevelopment Plan for West Broadway NDP Urban Renewal Area (1) as amended by the following Ordinances of the City of Providence: Chapter 1974-38, (November 11, 1974); Chapter 1975-31, (December 13, 1975); Chapter 1976-16, (April 16, 1976); Chapter 1977-4, (February 14, 1977); Chapter 1978-16 (June 24, 1978); Chapter 1978-28, (December 29, 1978); Chapter 1984-19, (March 9, 1984); Chapter 1992-46, (November 25, 1992) Chapter 1997-13, (February 23, 1997), and Chapter 1998-7, (January 16, 1998), is hereby amended as follows:

- A. 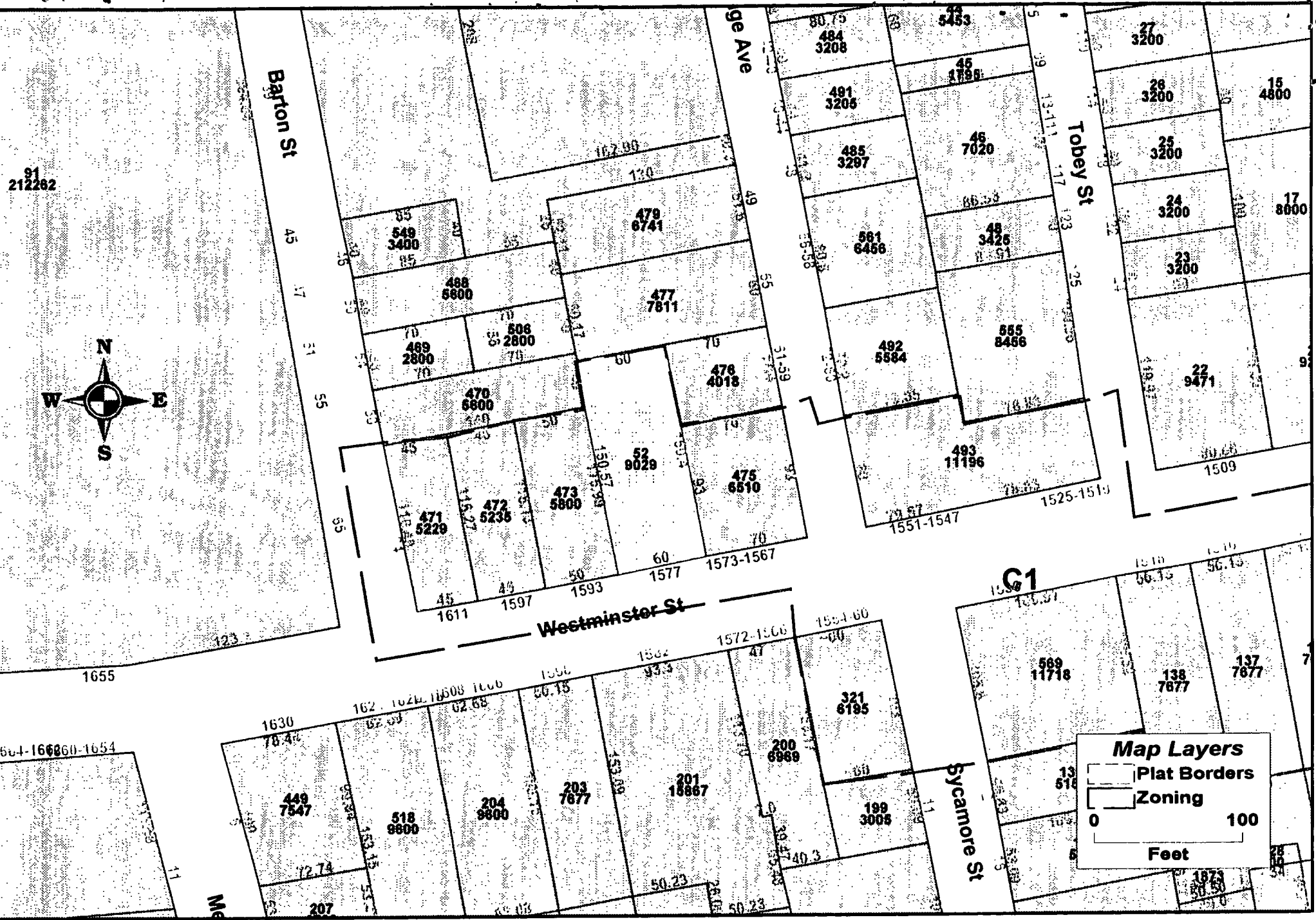
