# RESOLUTION OF THE CITY COUNCIL

No. 671

Approved December 26, 1967

WHEREAS, the Secretary of the Department of Housing and Urban Development is authorized under Section 314 of the Housing Act of 1954, as amended, to make urban renewal demonstration grants to assist public bodies in developing, testing, and reporting methods and techniques, and carrying out demonstrations and other activities for the prevention and elimination of slums and blight; and

WHEREAS, it is in the public interest that the City of Providence avail itself of this financial assistance to carry out the urban renewal demonstration project generally described as:

"A Study of Renewal and Redevelopment in the Form of a Motion Picture, with Particular emphasis on How the Federal Government Works with the Cities"

and;

WHEREAS, it is recognized that the Federal contract for such financial assistance pursuant to said Section 314 will impose certain obligations and responsibilities upon the City of Providence and will require among other things the provision by it of the local share of project cost and other local obligations and responsibilities in connection with the undertaking and carrying out of the project; and

WHEREAS, Title VI of the Civil Rights Act of 1964, and the regulations of the Department of Housing and Urban Development effectuating that Title, provide that no person shall be discriminated against because of race, color, or national origin in the carrying out of the urban renewal demonstration project:

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PROVIDENCE, That the filing of an application on behalf of the City of Providence for an urban renewal demonstration grant under said Section 314 in the amount of \$50,000 for undertaking and financing the project, is hereby approved, that the United

AN ACT

AUTHORIZING THE CITY OF PROVIDENCE TO APPROPRIATE AND PAY TO THE HEIRS OF THE LATE COUNCILMAN CHARLES H. O'CONNOR, THE BALANCE OF HIS SALARY.

It is enacted by the General Assembly as follows:

SECTION 1: The City Council of the City of Providence is hereby authorized and empowered to appropriate and pay to the heirs of the late Councilman Charles H. O'Connor the balance of the salary of said Charles H. O'Connor, for the period August 10, 1907 to November 15, 1907.

SEC. 2: This Act shall take effect upon its passage, and all Acts and parts of Acts inconsistent herewith are hereby repealed.
