

During the period from 1953-65 Mr. Mallozzi gained wide experience on many large-scale projects in the offices of various prominent architectural firms throughout the U.S. In 1965 he began private practice as a partner in the firm Mallozzi Associates, and when the firm was incorporated, served as President from 1968-1973.

In 1974 he established with his associates the joint venture firm of Americo Mallozzi/Koulbanis Brandreth Associates, Associated Architects, with offices in Providence and New York, and established the new firm of Americo Mallozzi + Associates, Providence, Rhode Island.

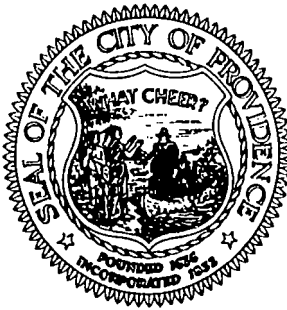
