No. 172 **AN ORDINANCE** AMENDING CHAPTER 16 "OFFENSES AND MISCELLANEOUS PROVISIONS", ARTICLE III, "NOISE CONTROL", TO ADD SECTIONS 16-108 AND 16-109.

*Approved* April 24, 1989

*Be it ordained by the City of Providence:*

SECTION I. That Chapter 16 "Offenses and Miscellaneous provisions", Article III "Noise Control", be amended to add Sections 16-108 and 16-109, as follows:

Sec. 16-108. General Noise Regulations --Notwithstanding any other provision of this Chapter, and in addition thereto, it shall be unlawful for any person to willfully make or continue, or cause to be made or continued, any loud, unnecessary, excessive or offensive noise as defined in Section 16-92(m) above.

Sec. 16-109. Complainants. Any person including a police officer, may be a complainant for the purpose of instituting action for any violation of this Article III.

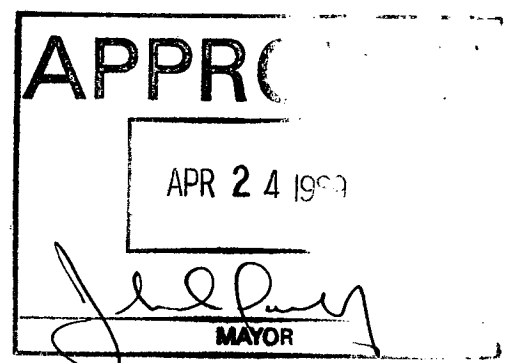
SECTION II. This Ordinance shall take effect upon its passage.


Dear Rose:
