RESOLUTION APPROVING AND PROVIDING FOR THE EXECUTION OF A CODE ENFORCEMENT PROGRAM FIRST AMENDATORY CONTRACT AMENDING CONTRACT FOR CODE ENFORCEMENT GRANT CONTRACT NO. R. I. E-1 (G) BY AND BETWEEN THE CITY OF PROVIDENCE, RHODE ISLAND AND THE UNITED STATES OF AMERICA

BE IT RESOLVED BY THE CITY COUNCIL OF PROVIDENCE, RHODE ISLAND, AS FOLLOWS:

Section 1. The pending proposed Code Enforcement Program First Amendatory Contract (herein called the "Amendatory Contract"), to amend that certain Contract for Code Enforcement Grant Contract No. R. I. E-1 (G), dated the 10th day of June, 1966, by and between the City of Providence, Rhode Island (herein called the "Local Public Agency") and the United States of America (herein called the Government"), is hereby in all respects approved.

Section 2. The Mayor of the City of Providence is hereby authorized and directed to execute the Amendatory Contract in two counterparts on behalf of the Local Public Agency, and the City Clerk is hereby authorized and directed to impress and attest the official seal of the Local Public Agency on each such counterpart and to forward such counterparts to the Department of Housing and Urban Development, for execution on behalf of the Government, together with such other documents relative to the approval and execution of such counterparts as may be required by the Government.

Section 3. This Resolution shall take effect immediately.

WHEREAS, John A. McConnell, late a Commissioner of the Estate of Charles H. Smith, whose service for the City of Providence, in that capacity, began February 2, 1950, was called by Almighty God to his eternal reward, and

WHEREAS, in his life-span of eighty two years, John A. McConnell, departed from an unprecedented career of leadership in behalf of organized labor, prominent in that area being his devotion to the Brotherhood of the Almagamated Association of Street Electric Railway and Motor Car Operators, in which he served for nearly one third of a century, until his retirement, and

WHEREAS, the accolades he received and of which he was duly entitled as President of the Providence Central Federated Council; as a Member of the New England National War Labor Board; The New England Wage Stabilization Board; Delegate to the International Labor Conference in Milano, Italy; State Vice President of the American Federation of Labor and State Trustee of the American Federation of Labor, and the Congress of Industrial Organization, and

WHEREAS, active in Democratic Politics, he served as a Ward Committeeman in the Third Ward in the City of Providence and a Delegate from the State of Rhode Island to the Democratic National Conventions of 1948 and 1952, and as a further public service, he served as a Member of the Providence Human Relations Commission, and

WHEREAS, prominent in the affairs of the Roman Catholic Faith, Brother McConnell was a Past President of the Holy Name Society of St. Raymond's Church in Providence and the recipient of the St. Antoninus Award of the Thomistic Institute of Industrial Relations at Providence College,
