## PERSONAL PRIVILEGE

COUNCILMAN CLARKIN requests the privilege of the Floor to speak on a Point of Personal Privilege and states:

"This Resolution concerns parking. Special Interest Parking. The parking on City Streets by Court Employees. The illegal appropriation of City Street Monies for a Special Interest. Around 140 Parking Places have been taken over for the use of Court Employees and mind you, many of the Signs that say "No Parking — Court

Employees Only" were not put up by the City. They were put up by Court Employees. They have made City Streets into a private parking lot. They reserved parking for themselves and they have made themselves a private parking area. While denying residents of that area the right to seek and that is all they ask is for the right to seek a Parking Space near their home.

I have looked through the List of Fines for Illegal Parking and nowhere do I see a fine for

parking in Court Employee Spaces. The Traffic Engineer can regulate parking when it concerns the movement of traffic through our Streets and yes, the Traffic Engineer can allow Emergency Parking or Emergency No Parking. But, only for a limited amounts of time.

Nowhere does the Law allow the Traffic Engineer to abandon a Street and that is just what has been done. We have abandoned parts of these Streets and turned them over to Special Interests. Neither the Traffic Engineer nor the Mayor can abandon a Street, only this Body has that power.

Why are Court Employees guaranteed First Class Parking at no cost, while the residents, the taxpayers are treated like Third Class? The Department of Transportation is always pushing for the taking of the Bus. Let us tell these Court Employees to take the Bus!

I ask you to join me in saying "No" to Special Interests. Thank You."
