PETITION TO THE CITY COUNCIL

TO THE HONORABLE CITY COUNCIL OF THE CITY OF PROVIDENCE:

*The undersigned respectfully petitions your honorable body*

That Donstan Corporation is the owner of a certain Parcel of Real Estate consisting of land and buildings and designated as Plat 62, Lot 393, as appears of record in the Office of the Assessor of Taxes for the City of Providence as of December 31, 1964. Said property is designated as 166 Valley Street, Providence, Rhode Island. The property consists of 289,403 square feet of land, together with various buildings thereon. The assessed value of said land is \$69,650.00, and of the buildings, \$330,180.00.

The General Assembly of the State of Rhode Island, at its January Session 1960 by Chapter 105 enacted legislation entitled "Act Authorizing the City of Providence to Construct a Hurricane Barrier". Section 12 of said Chapter reads as follows: "In order to help defray its share of the cost of said hurricane barrier, the City of Providence is authorized to assess the owners of land and buildings within the area classified as being vulnerable to hurricane, flooding and tides."

This Honorable City Council, by Resolution numbered 308 determined the fact that the land of your Petitioner vulnerable to hurricane, flooding and tides consisted of approximately 12,092 square feet of land containing no buildings whatsoever thereon. However, the assessment made by this Honorable City Council was upon the entire lot of land above described, together with all the buildings thereon; that the assessment so made by this Honorable City Council is directly contrary to the Enabling Act under which the Resolution numbered 308 was adopted, and is contrary to this Honorable City Council's designation of the "area classified as being vulnerable to hurricane, flooding and tides".

WHEREFORE, your Petitioner prays that this Honorable City Council abate all hurricane barrier assessments against the Petitioner assessed as of May 23, 1966, except as it may pertain to 12,092 square feet of land without buildings.

## PETITION TO THE CITY COUNCIL

TO THE HONORABLE CITY COUNCIL OF THE CITY OF PROVIDENCE:

*The undersigned respectfully petitions your honorable body*

that it is the owner of certain real estate situated in the City of Providence, State of Rhode Island, and that it has received a bill from the City Collector of Taxes for said City of Providence for a Hurricane Barrier Bill which was assessed on May 23, 1966; that there were three items on this bill, one of which, namely, Lot No. 30 on Plat No. 10, is owned by the undersigned, on which the assessment was made of \$437.40, the first installment currently due being in the amount of \$17.50; that on said tax bill there was taxed to your petitioner assessments on two lots which your petitioner has never owned, although your petitioner does own the building situated on said land, for which rent is paid to the owner of said land; that said assessments are on Plat No. 4, Lot 16, in the amount \$47.25, and on Plat No. 4, Lot 224, in the amount \$115.56; that said assessments are illegal and erroneous, as it is the understanding of your petitioner that the taxes assessed under the Hurricane Barrier Bill should be assessed against the owner of the land and not against your petitioner as the tenant of the premises under a lease in which the petitioner is the owner of the buildings only and not the owner of the land.

Petitioner therefore respectfully petitions that the Honorable City Council of the City of Providence abate, cancel and discharge said assessments in the amounts \$47.25 and \$115.56, respectively, as said assessments are erroneous and illegal.
