Gentlemen:

Receipt of Resolution of the City Council No. 63 approved January 18, 1963 is herewith acknowledged.

The purpose of the said resolution requests the Director of the Providence Redevelopment Agency "to undertake consideration of an Urban Renewal Project within the South Providence Area, so called, to extend and implement the renewal program commended with the Point Street Redevelopment Project".

There are several factors which must be given consideration before the Providence Redevelopment Agency can undertake a renewal program in the South Providence Area, so called, or in any area of the City of Providence. These conditions are:

1. Eligibility of proposed area.
2. Impact on displacement of families and businesses.
3. Marketability of proposed renewal area.
4. Schedule of Redevelopment activities as proposed by the Community Renewal Program.
5. Ability of City to finance the proposed redevelopment.
6. Current workload of the Providence Redevelopment Agency.

Points one, two and three, I suspect, after specific study, would all result in a finding of feasibility for the subject area. However, of the six listed conditions above, the latter three in my opinion would necessarily deter Agency activity at this time.

Initiation of Redevelopment programs by priority of City importance will be forthcoming from the current study of the Community Renewal Program. It will be the decision of the Administration in its proper role of coordination and integration of various types of urban renewal activities to select the program areas. In this way the City will greatly realize economies of capital expenditures while at the same time it will stretch our local dollars by affording greater financial participation federally in the redevelopment program.

Whereas, the benefits derived from renewal are of tremendous importance to the vitality of our city, I believe the City's ability to finance additional redevelopment work at this time should be given deliberate analysis. Since ultimately the cost of a redevelopment project must be incorporated into the City's financial structure, the City not the Providence Redevelopment Agency has the responsibility and the prerogative if you will, to advise the Agency as to what to study and develop in the overall plan for renewal.


Finally, there is a shortage nationally of trained personnel in the field of urban renewal programming. Providence has fared only reasonably well in maintaining a staff equipped to do its current programs. As a matter of fact, only due to the exceptional experience and dedication to the task have the men and women of the Providence Redevelopment Agency been able to cope with heavy assignments of three projects in survey and planning and four projects in various stages of development. It is my opinion, unless there develops an appreciable reduction in the current workload, it would be disastrous to attempt another renewal project.

I am probably the only Redevelopment Director in the nation that has reported to his City Council reasons why it would be inappropriate to initiate a redevelopment project. Many of my colleagues across the country labor, and many times fruitlessly, the issues for redevelopment with their legislative bodies. The program of renewal in Providence, however, is indeed fortunate to enjoy the continuing support of the successive administrations of former Mayor Dennis J. Roberts and Mayor Walter H. Reynolds, both political parties in the City Council, a strong and informative press, and generous citizen acceptance.

Whatever history may account for this period of time in the life of the City of Providence, I strongly suspect that it will note the vigorous efforts made by it under the policy directives of the City Fathers to renew the Capital city of Rhode Island as a better environment for all its citizens.

I am grateful to be a part of it.


