WHEREAS, the comprehensive plan must be consistent with the goals of the Act and the State Guide Plan, and must contain nine elements as set forth in the Act; and

WHEREAS, the comprehensive plan must be carried out through specific public actions and through amendment of the zoning ordinances so as to conform with the comprehensive plan; and

WHEREAS, the Act makes grants available to assist municipalities to comply with its requirements, and the City of Providence desires to obtain such financial assistance;

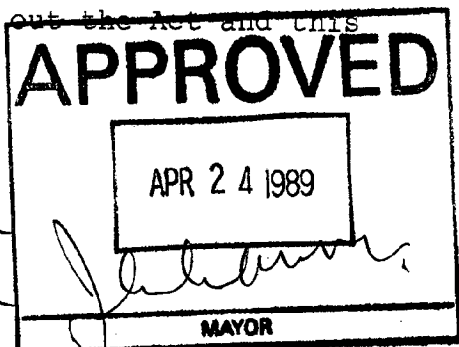
NOW THEREFORE, the Council of the City of Providence does resolve that:

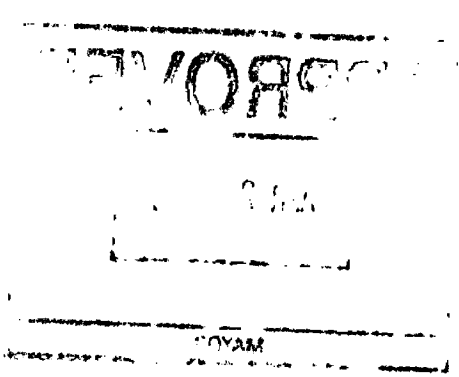
