Whereas, A report by a Committee Created to Study the Feasibility of the Establishment of a Law School at Providence College, led by Presiding Justice, Joseph R. Weisberger of the Superior Court, as Chairman, Reverend Cornelius P. Forster, O.P., Vice-Chairman of Providence College and twelve Members of the Rhode Island Bar, it recommended the establishment of a Law School at Providence College, and

Whereas, The Committee's findings, which covered the areas of financing, through funding from Governmental, Foundation and Individual Sources, reported the benefits which would accrue to students within closer proximity to Providence College, rather than some of the number of outstanding Law Schools in the Boston Area and at Yale Law School in Connecticut, and

Whereas, The said Committee concluded that applicants from the State of Rhode Island and possibly nearby Massachusetts and Connecticut, could support, with its tuition fees, one Law School with the classes aggregating a total of up to 450 students,

Now, Therefore, be it Resolved, That in light of the Committee's report, the City Council does hereby endorse the same incorporated in the subject report, a copy of which is hereto attached, and does, within the scope of its authority, encourage the modification and refurbishing of buildings located on the Chapin Campus, that they may be utilized as a physical plant needed to establish and conduct such a graduate school, and

Be it further Resolved, That to Chief Justice Weisberger, Reverend Forster and Messers. Fanning, E.V. Higgins, J.A. Higgins, Kelleher, McGowan, Monti, Murray, Partridge, Pucci, Travis, J.W. Walsh, and S.R. Walsh, are hereby extended the congratulations of this Body, for their comprehension of the need that has existed in the State of Rhode Island for the establishment of an accredited Law School.

COUNCILMAN FLYNN Requests and is Granted the Privilege of the Floor on a Point of Personal Privilege and Reads and Submits to the Clerk, the Following Statement:

Mayor Cianci has consistently shown a lack of concern for the problems of the West End. One major West End problem which Cianci has treated solely in terms of partisan politics is Recreation.

Last November, Mayor Cianci signed a Resolution which I sponsored for lighting at Dillon Field (Bucklin Park), lights which were needed for practice by an area football team — the West End Intruders.

Almost a year later, Cianci has failed to answer this problem. While I noted there is no money in the budget, Cianci has made it a practice in the past to transfer Community Development money for Recreational programs. Why hasn't he used Community Development Money for the installation of lights at Bucklin Park? The answer is simply, that contrary to what Cianci hypocritically preaches, he does place politics before people and their problems.

Why is that with the City's hopes for a 2.6 million dollar grant from the Economic Development Act, there is no mentioning of any plans for earmarking of these funds for the West End? Why is this money only planned for Recreational purposes in Silver Lake, North End and Blackstone Boulevard? The answer, again, is politics.

The West End has an urgent need for improved Recreational facilities. Cianci has subordinated these needs, as well as others, in his desire, to reward Councilmen who vote with him and punish those who vote against him by ignoring the area's problems.

As for the West End, it has been a case of continuous neglect by Cianci as witnessed by our poorly swept streets, inadequate police protection and the absence of cleanup drives.

If Cianci were truly concerned with people, not politics, he would have installed those lights at Bucklin Park a long time ago.
