<i>Agenda Item No.</i>	<i>Description</i>	<i>Department Response</i>
1.	Resolution Requesting the Traffic Engineer to cause the feasibility of a traffic study for Priscilla Avenue and Dora Street due to excessive speeding.	Traffic counts were obtained on Dora Street between September and December of 2013 on Dora Street and there was no evidence of a speeding problem.
2.	Resolution Requesting the Traffic Engineer to cause the installation of speed bumps along Ayrault Street.	This request was reviewed and conditions do not warrant the installation of speed bumps at this location.
3.	Resolution Requesting the Traffic Engineer to cause Gordon Avenue, between Potters Avenue south to Oxford Street, to be established as a "One-Way" Street.	Signs have already been installed
5.	Resolution Requesting the Acting Director of Public Works to recycle street sweeping sand on city streets to be reused in 2014-2015 Winter Season.	After being applied to the street, the particle size of sand is significantly reduced so as to be less effective in providing traction for vehicles. Furthermore, the reduced size is more likely to be carried through the stormwater system and could be deposited in a brook or stream, causing an environmental problem. Also, the cost of
