That

the following named person, firm or corporation is hereby granted permission to erect, alter or use a building or structure at the location named herein for the sale of petroleum, kerosene, gasoline, coal oil and their products, compounds and components as described and shown in and on the application therefor and accompanying plat, all on file in the Office of the Department of Building Inspection subject to the conditions that said person, firm or corporation shall not violate any of the laws of the State of Rhode Island or any of the Ordinances of the City of Providence relative to the erection, use or occupation of said structure and that said person, firm or corporation shall not allow petroleum, kerosene, gasoline, coal oil or their products, compounds or components, to be conveyed over or across any sidewalk by means of any pipe or hose, and upon such special conditions as are hereby enumerated and further provided that the Director of the Department of Building Inspection may authorize minor changes in the structural detail of plans on file, viz:

WARD 5. JOHN VOLPE, 113 Harold Street, Plat 65, Lot 200,
2-3,000 gallon gasoline storage tanks and 1-100 gallon
waste oil storage tank making a total capacity of
6,100 gallons upon the premises, and two pumps.

The erection or location of any buildings or structures not shown on the original plat on file with the Director of Department of Building Inspection, or any change in the location of buildings or structures from that shown on said plat shall be deemed a violation of this permit.

RESOLUTION OF THE CITY COUNCIL

Approved

Resolved,

That

the City Council does hereby request the Mayor to direct the Commissioner of Public Safety to rescind his directive that will allow members of the Police Department to engage in private outside employment, and to further direct the members of the Fire Department to cease engaging in such employment, for the following reasons:

1. That no policeman should work more than 40 hours a week, except for extra necessary duty or for special details.
2. That no fireman should work more than 56 hours a week, except for emergencies within the Department.
3. That no policeman or fireman can physically or mentally, after a day's tour of duty, then engage in a second job and be refreshed in body and mind for the next day's tour of duty.
4. That it is degrading and induces a lack of respect by the public for our law enforcement officers to engage in outside jobs.
5. That the salaries of the men in these departments shall be increased so that they receive a fair and decent salary that is comparable to the salaries paid in progressive cities throughout the nation.

And be it further resolved,

That the Mayor is requested to occasion the introduction of an ordinance to increase the salaries of the members of the Police and Fire Departments to a basic salary of \$100.00 a week, with commensurate increases for superior officers, and that the funds necessary for this purpose be transferred from surplus, anticipated surplus, or be otherwise obtained by economies to be effected within the city government.
