IN AMENDMENT OF CHAPTER 564 OF THE ORDINANCES OF THE CITY OF PROVIDENCE ENTITLED " THE CITY OF PROVIDENCE ZONING ORDINANCE" APPROVED JUNE 27, 1994, AND AMENDED MAY 26, 1995, BY AMENDING PROVIDENCE ZONING DISTRICT MAP NUMBER 43 OF THE OFFICIAL ZONING MAP BY CHANGING THE ZONING DISTRICT DESIGNATION OF LOTS, 385 and 386 FROM R-3 TO C-2.

Approved March 13, 1997

Be it ordained by the City of Providence:

Section 1 : Chapter 564 of the Ordinances of the City of Providence, entitled " The City of Providence Zoning Ordinance" approved June 27, 1994, and amended May 26, 1995, is hereby amended by changing the zoning district designation of lots, 385 and 386 on Providence Zoning District Map 43 of the Official Zoning Maps from R-3 to C-2.

Section 2 : This Ordinance shall take effect upon passage.

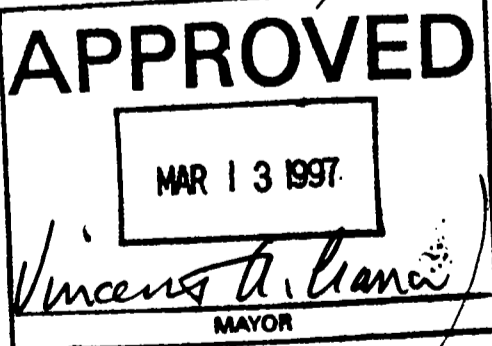
