AN ORDINANCE AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1981-39, EFFECTIVE JULY 20, 1981 BY TRANSFERRING THE SUM OF NINETY THOUSAND DOLLARS (\$90,000.00) FROM PUBLIC WORKS - HIGHWAY, ITEM 1, TO PUBLIC WORKS - HIGHWAY, ITEM 2.

Be it ordained by the City of Providence:

SECTION 1. Chapter 1981-39 of the Ordinances of the City of Providence entitled: "An Ordinance Making an Appropriation of One Hundred Forty-Nine Million, Eight Hundred Sixty-Two Thousand, One Hundred Twenty-Two Dollars, Nine Cents (\$149,862,122.09) for the Fiscal Year Ending June 30, 1982", effective July 20, 1981, as amended, is hereby amended by transferring the sum of Ninety Thousand Dollars (\$90,000.00) from Public Works - Highway, Item 1, to Public Works - Highway, Item 2.

SECTION 2. This Ordinance shall take effect upon its Passage.
