Rental payments shall commence April 1, 1987 and shall be as follows:

April 1, 1987 through March 1, 1992 at the rate of Two Hundred Eighty-Five Dollars (\$285.00) monthly;

April 1, 1992 through March 1, 1996 at the rate of Four Hundred Dollars (\$400.00) monthly;

April 1, 1997 through March 1, 2002 at the rate of Five Hundred Dollars (\$500.00) monthly;

April 1, 2002 through March 1, 2007 at the rate of Six Hundred Dollars (\$600.00) monthly.

The Lessee shall open for business not later than nine (9) months from the execution of the lease documents.

The Lessee shall make alterations to the realty substantially in accordance with those design plans submitted to the City of Providence, which are attached hereto and made a part hereof (Attachments 1, 2, 3, & 4), and such alterations shall be not significantly less than the sum of Sixty Thousand Dollars (\$60,000.00).

Should the Lessee fail to abide by either of the last two covenants, the lease shall become null and any improvements theretofore undertaken shall become the property of the City of Providence without recourse of the Lessee, and
