
The resolution of the Honorable City Council of the City of Providence, No. 204, approved on April 9, 1976, and received by the Board of Elections on June 3, 1976, was placed on the agenda of the Board at a meeting held on June 4, 1976.

After lengthy consideration and deliberation, and upon the advice of its legal advisor, the Board of Elections is unanimously of the opinion that to legally interpret the words "Residence" and "home" as incorporated in the election laws would be an infringement upon the rights and powers of the courts of the State of Rhode Island. The Board respectfully refers the Honorable City Council to "Opinions of the Justices", 65RI at Page 452" in which opinion our Supreme Court legally and clearly defines the words "residence" and "home" as incorporated in the election laws.


The Board trusts that this will be of assistance to the Honorable City Council.
