That the following streets: Whelan Road, from Flower Street to its easterly termination; Barry Road, from Hartford Avenue, northerly and easterly to its easterly termination; Bodell Avenue, from Whelan Road to Hartford Avenue and from Hartford Avenue, southerly and easterly to the junction of Etna and Cleveland Streets, shown shaded on that certain plat, entitled "Street Layout, Hartford Park & Hartford Park Extension, The Housing Authority of the City of Providence, Rhode Island, January, 1958 - By N. M. Verde - Scale: 1" = 80' " are hereby declared public highways to be repaired at the expense of the City, the same having been dedicated for highway purposes under the provisions of Chapter 987 of the Public Laws of 1913.
