Be It Further Resolved, That upon the completion of such investigation, the said Committee report its findings to the City Council, for the

purpose of recommending implementation of any additional necessary safety factors that it may deem are required, that such a disaster that occurred at the Staten Island facility may be eliminated in the City of Providence.
