PERSONAL PRIVILEGE

COUNCILMAN CLARKIN requests the floor to speak on a Point of Personal Privilege:

"In the Iraq War we heard about the Stealth Bomber. It is a Bomber that cannot be seen by radar. To the enemy, it is invisible. It does not exist to radar. It cannot be picked up by any known means.

We in Providence have our own version of Stealth. It is the injuries that our firefighters get. They cannot be seen by x-rays, they are invisible, they are non-existent. To put it bluntly, they are phony.

Richard Connelly, the firefighter that just received a disability pension is only an example of the 90% of those firefighters that went off with a disability pension. He is a phony and most of the others with a disability pension are phonys also. 90% of the 150 firefighters that have retired went off with a disability pension. Why is this allowed to happen? I'll tell you why. We allow it, we on this Council allow it. We have the power to say "No". We have the power to stop this abuse. I have heard many times that there is nothing we can do, that it is in the Contract, baloney. We do not have to accept any Contract that is wrong and let me tell you, the firefighters' Contract is wrong. Who among you think that we should give Richard Connelly's children priority for a job on the Fire Department. We will have to if we approve the present firefighters contract.

What are some of the benefits Richard Connelly gets for his so-called disability? He gets a tax free income. He can go to State College for free. His children can go to a State College for free, and he gets paid Blue Cross for life. This for a man who cannot wrestle with a hose because he has a sore back. But, now he is a Guard at the State Prison. What happens if he has to wrestle with

a prisoner? Richard Connelly is not an aberration. Richard Connelly is the norm.

This group of firefighters are not the firefighters that I remember. Jack Seddon, Sidney Lema, Manny Lima, Cap Turbidy, Lt. Lynch, the MacDermonts, these were good guys, these were honorable men. There are still some honorable men on the Fire Department but they are out numbered by the rip off artists. This group is only out to get what they can. Screw the taxpayers. Check the injured on duty list. Each summer or holiday, it jumps with the same guys going out. These are not good guys. They are only out for more overtime and trying to get an early pension. How much more can the taxpayers of the City put up with? How many more scams from these firefighters can this city put up with?

Their Union Leaders tell they are stressed out from all the work they do. They recently put out a newspaper, a paper that stated how many fires they fought. I won't bore you with details, I've given you all a breakdown of the few fires that they fought. The only stress they are under is the stress of coming up with new ways of ripping the taxpayers off. This rape, and that is just what they are doing, raping the taxpayers of this City must stop.

We are passing out pensions to men in their late twenties and early thirties, lifetime pensions for minor or non-existent injuries. No system can survive with the amount of abuse this pension system is asked to take, it must stop. I've asked that this body appoint a Board to look into the Pension abuses. As of today, it is still in Committee. I ask, I beg, I plead with you to set up this Committee. We must open up the secret

process that is used. The medical records must be looked at, we must see just what injuries the firefighters claim to have.

We make the laws, we set up what benefits the Pension Board pays out. Maybe it is time that we do away with the two-thirds disability pay. Maybe we can go to the Military System, only pay for the percentage of the lost ability to work at another job. There is one thing that all of the injuries have in common. It is that almost none are truly disabling. Most of those with a Disability Pension can (just like Richard Connelly) work at another job.

Finally, let me say that minimum manning is a joke. We do not need more firefighters in this City. Rather, we should be closing fire stations and lowering our manpower. Overtime in May

was \$268,000.00, not because of injuries as you will be told, but because of the scams the firefighters pull.

Barrington is looking into doing away with their Fire Department and going back to a Volunteer Department. A Fire District in Lincoln has done away with their Fire Department and returned to a Volunteer Department. Warwick is checking on privatizing their Rescue Units. We will be the only City in the Whole Country that is expanding their Fire Department.

We were elected to be leaders of this City. Let us take a stand and stand up to those that are the worst abusers of the System. Let us say no more to the firefighters.

ADJOURNMENT

There being no further business, on motion of COUNCILMAN GLAVIN, seconded by COUNCILMAN LOMBARDI, the City Council voted to adjourn at 8:30 o'clock P.M. (EDT) to meet again on THURSDAY, AUGUST 6, 1992 at 7:30 o'clock P.M. (EDT).
