Approved May 3, 1983


RESOLVED (1) That the City Council urge the passage  
by the General Assembly of that Act entitled:


AN ACT RELATING TO RETIREMENT OF EMPLOYEES OF  
THE CITY OF PROVIDENCE

which would alter existing law to enable any member of the  
Retirement System of the City of Providence who has been  
retired prior to 1974 with a so-called disability pension  
to purchase for pension purposes time spent in the military  
and increase his or her disability pension by the stated amounts.

BE IT FURTHER RESOLVED (2) That the City Solicitor is  
directed and authorized to take whatever steps are necessary  
to assist in the passage of said act, substantially as set  
forth in the proposed bill attached.

1 year for each year purchased, added to whatever pension benefit  
2 that is currently payable for his previous employment in the city,  
3 including those retired members who received disability retire-  
4 ment benefits.

5       Upon such payment, notwithstanding any general or public  
6 law or special enactment to the contrary, that in the event a  
7 member is retired and receiving ordinary or disability benefits,  
8 his retirement benefit shall be increased an additional two  
9 (2%) percentum per annum for each year purchased for the period  
10 of service in the armed forces or merchant marines, and further,  
11 shall be increased even in those cases that would increase  
12 the retirement benefit beyond sixty-six and two thirds (66 2/3%)  
13 percentum. The credit of such service shall be both for the  
14 purpose of recomputing the amount of pension which is payable  
15 under this act and the rights of any beneficiary claiming  
16 through him.

17       SECTION 2. Nothing in this act shall be construed to be  
18 a state mandated cost subject to reimbursement by the state  
19 pursuant to chapter 45-13 of the general laws.

20       SECTION 3. This act shall take effect upon its passage.
