No. 341 **AN ORDINANCE** IN AMENDMENT OF ARTICLE V 1/2 OF THE CODE OF ORDINANCES OF THE CITY OF PROVIDENCE, RHODE ISLAND ENTITLED "REAL PROPERTY TAX EXEMPTION FOR THE DISABLED" AND ARTICLE V OF THE CODE OF ORDINANCES OF THE CITY OF PROVIDENCE, RHODE ISLAND ENTITLED "REAL PROPERTY TAX EXEMPTION FOR ELDERLY."

*Approved* July 1, 1988

### *Be it ordained by the City of Providence:*

Section 1. Sections 21-121 and 21-122 of Article V 1/2 of the Code of Ordinances of the City of Providence, Rhode Island entitled "Real Property Tax Exemption For The Disabled" are hereby amended by changing the phrase "three thousand dollars (\$3,000.00)" wherever appearing therein to the phrase "nine thousand dollars (\$9,000.00)."

Section 2. Section 21-111 of Article V of the Code of Ordinances of the City of Providence, Rhode Island entitled "Real Property Tax Exemption for Elderly" is hereby amended by changing the phrase "three thousand dollars (\$3,000.00)" to "ten thousand dollars (\$10,000.00)" appearing therein.

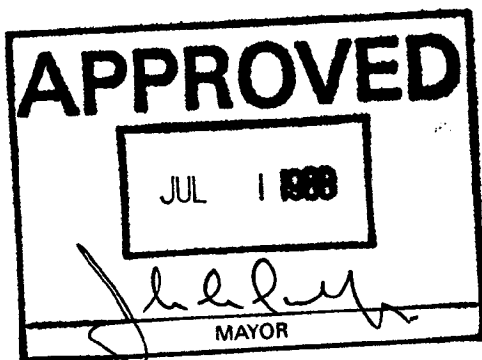
Section 3. This Ordinance shall take effect upon its passage.
