


Dear Mr. Clement:

RESOLUTION OF THE CITY COUNCIL

No. 232

Approved April 9, 1998

WHEREAS, 7 Pallas Street (A.P. 28 Lot 31) has been vacant and tax delinquent for many years.

WHEREAS, 7 Pallas Street has been neglected and presently meets the criteria and definition of a blighted area in accordance with Rhode Island General Laws Section 45-31-8.

NOW, THEREFORE, The City Council resolves that 7 Pallas Street must be put to beneficial use for the City of Providence, in accordance with Providence 2000 - The Comprehensive Plan and the Zoning Ordinance.

The City Council further resolves that:

1. The City Treasurer shall be instructed to work with the Providence Redevelopment Agency to foreclose the right of reverter on 7 Pallas Street, in accordance with Section 2-75 of the City Code of Ordinances, and
2. The City shall transfer 7 Pallas Street to the Providence Redevelopment Agency once the title rests with the City, and
3. Such Agency shall dispose of 7 Pallas Street to the abutters in accordance with state laws governing redevelopment agencies and the reuse of property shall be in accordance with the City's Zoning Ordinance.
