No. 244 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1979-30, APPROVED JUNE 22, 1979, BY TRANSFERRING CERTAIN SUMS OF MONEY WITHIN THE DEPARTMENT OF PUBLIC WELFARE.

*Approved* May 3, 1980

### *Be it ordained by the City of Providence:*

Section 1. Chapter 1979-30 of the Ordinances of the City of Providence, as approved June 22, 1979, and Entitled: "An Ordinance Making an Appropriation of \$117,978,739.44 for the Support of the City Government for the Fiscal Year Ending June 30, 1980," is hereby further amended by appropriating the sum of Eight Hundred Thousand Dollars (\$800,000.00) within the Department of Public Welfare as follows:

- Item 1  
(1-10-03-184) Hospitalization \$700,000.00
- Item 3  
(1-10-03-351) Public Welfare \$100,000.00

Section 2. The said sum of Eight Hundred Thousand Dollars (\$800,000.00) as thus added and appropriated shall be obtained by estimated increased revenues in the following item:

Grants In Aid State of R. I.

General Public Assistance \$800,000.00

Section 3. This Ordinance shall take effect upon its passage.

I am requesting a supplementary appropriation for my Hospitalization Account (Object Code #184) of seven-hundred thousand dollars (\$700,000.00). This is necessary due to our increased caseload in General Public Assistance for the past year and the increased medical costs which were not reflected in our budget request for the year.

I am also requesting one-hundred thousand dollars (\$100,000.00) for the Public Relief Payroll Account (Object Code #351). This is also necessitated by the increased caseloads and the increase standards above and beyond those projected for this year.

Dear Ms. Mendonca:

I am in receipt of your correspondence requesting additional information on my request for a supplementary appropriation for the Providence General Public Assistance program.

If the City Council were to reject the authorization for the supplementary appropriation, it would mean that approximately at the end of May, there would be no funds available to carry out the General Public Assistance program in Providence until the new fiscal year in July.

Currently, there are approximately 1300 active General Public Assistance cases in the City of Providence, and General Public Assistance is also used to provide initial needs in many Aid to Families with Dependent Children program cases.

The State will reimburse the City of Providence 100 per cent for the additional monies spent under this supplementary appropriation. The General Public Assistance program operates under Title 40, Chapter 6, Section 8 of the General Laws of the State of Rhode 1956 as amended.
