Dear Sir:

The section of Eddy Street proposed for  
abandonment is approximately 200 feet long and 40.12  
feet wide.

A 12-inch sanitary sewer is located in the  
street, as well as other public utility lines and ducts.

At the present time approximately 15 curb parking  
spaces are available to the public on the section proposed  
for abandonment.

The State of Rhode Island would acquire one-half  
and the Rodney Reynolds Realty Co. would acquire the other  
half of the area, if the proposed abandonment is approved.

Parking regulations now permit unlimited curb  
parking in this area and with the abandonment of the street,  
this area would become a private parking area.

Because of the utilities located in the street and  
also the elimination of public parking spaces, we recommend  
that the petition be denied.


The Rodney Reynolds Realty Company has petitioned your Committee to abandon as a public highway that portion of Eddy St. from Ship St. to the condemnation line of the North-South Freeway.

In this portion of Eddy St., we have a total of 157.70 ft. of 6" cast iron main, 101 ft. laid in 1872 and 56.70 ft. laid in 1956; also a 1 $\frac{1}{4}$ " service installed in 1908 and closed in 1933 for non-use, and a 6" fire supply installed February 9, 1956. The depreciated value of our facilities is as follows:

101 ft. of 6" cast iron main, laid in 1872	\$191.77
56.70 ft. of 6" cast iron main, laid in 1956	255.72
1 $\frac{1}{4}$ " lead service, installed in 1908	0
6" cast iron fire service, installed in 1956	<u>320.40</u>
Total depreciated value . . . . .	\$767.89

If this street is abandoned, the Rodney Reynolds Realty Co. will have to pay the City for the value of our facilities, which total \$767.89, and will have to relocate their 6" fire supply, which could be connected to an existing main from Richmond St. easterly along the northerly side of the building, or from the existing main in Ship St. on the southerly side of the building. There would be a connection charge which they would have to pay for this new fire supply, totalling \$400.00.

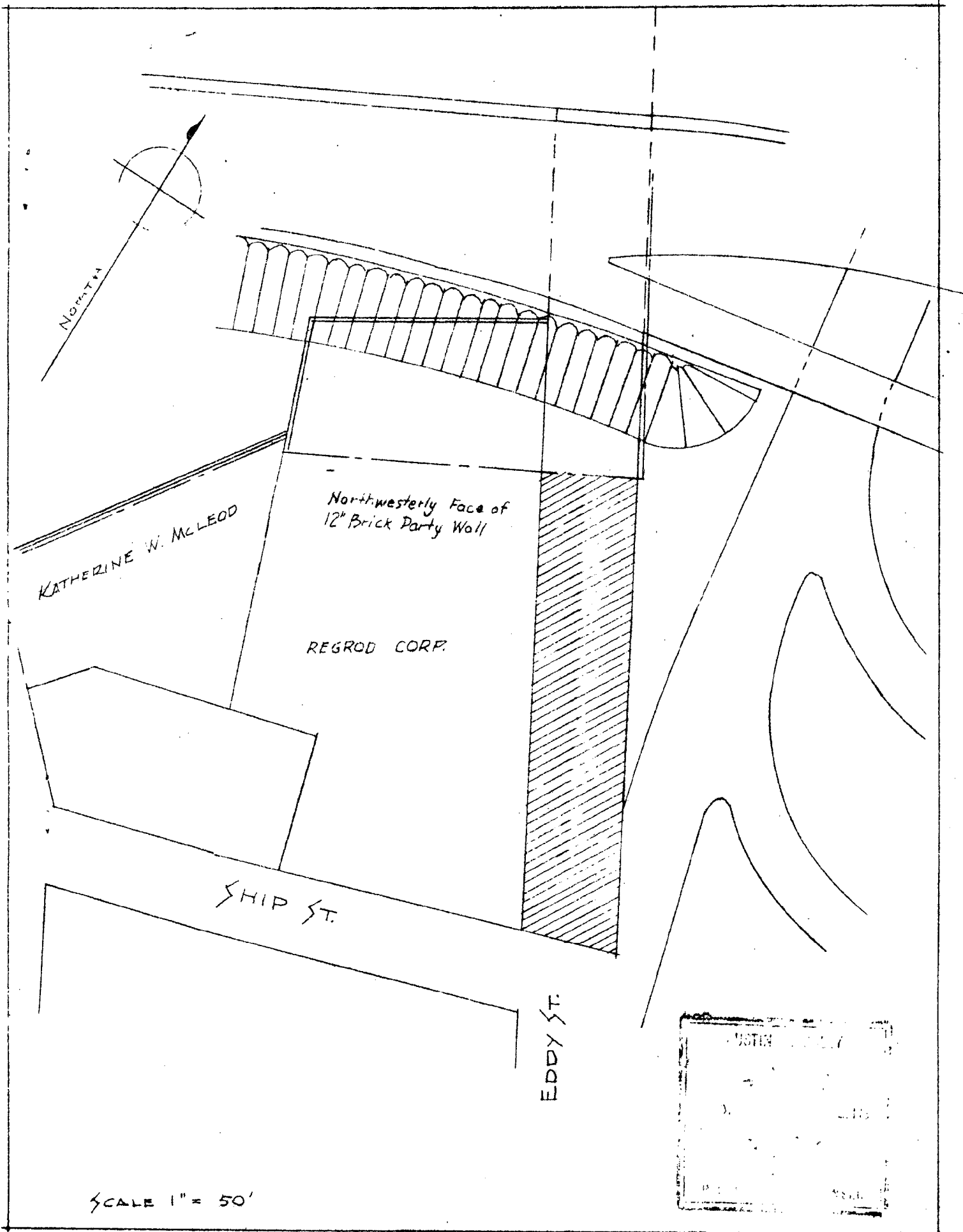

### QUARTERLY REPORT OF THE QUALITY OF MILK SOLD IN PROVIDENCE BY RETAIL DISTRIBUTORS

The following table gives the results of the average of analyses made by this department during the second quarter of the year 1958:

No distributor's name is listed under a particular grade of milk unless at least four samples of that grade were analyzed during the quarter. The standard plate count of colonies of bacteria is obtained by using the logarithmic average set forth in the United States Public Health Service Milk Code.

#### CERTIFIED MILK

The legal standards for Certified Milk are those adopted by the American Association of Medical Milk Commissions, Inc. and in effect at the time of production.

Unless otherwise indicated on the label it shall contain an average of 4.0% of butter fat with a minimum of 3.5% for individual samples and a minimum of 12% of total solids.

The average bacterial count of Pasteurized Certified Milk shall not exceed 500 colonies of bacteria per cubic centimeter.

#### GRADE A MILK—PASTEURIZED

Grade A Pasteurized milk is produced on farms scoring not less than 85% using the dairy score card of the U. S. Department of Agriculture. It shall have been pasteurized within 24 hours of the time of milking and delivered to the consumer within 30 hours after pasteurization. The butter fat shall average not less than 3.50% for any four samples taken in a period of not less than 30 days or more than 90 days. The bacteria count shall have a logarithmic average of not greater than 10,000 for any 4 consecutive samples.

The Total Solids Content shall average 12%.

The average bacteria count of pasteurized milk at the time of delivery to the consumer shall not exceed 25,000 per cubic centimeter and the average per centum of butter fat shall be not less than 3.25 per centum by weight.

The Total Solids content shall average 11.5%.
