Dear Mayor:

During the fiscal year ending September 30, 1953 the Office of the Recorder of Deeds received for record 19,036 documents. Our receipts were \$33,698.65. Expenses for the same period were \$55,245.01.

While the Office of the Recorder of Deeds was never intended to be a revenue producing department, I have always taken the position that it should be self-sustaining. During the thirteen years of my tenure of office, departmental expenses have soared to a record high.

When I assumed office in 1941, photostat paper used in the recording process cost \$25.70 per roll of 300 feet. At present a similar amount costs \$47.75. This is but an example of soaring costs both of material and labor over a period of the past decade.

However, our fees have been straight-jacketed by a statute geared to the costs of the 1920's. Our fees for recording purposes have not changed in the past twenty-five years.

At a meeting of the New York State Title Association held last October, serious attention was being given to a revision of the fee schedule for recording, with the idea that the fee charged at the time of recording, should cover not only the cost of indexing and transcribing the document on the record, but also the substantial cost of storing, rebinding and maintaining the records throughout the years to come.

At the present time in the office there are at least 500 books which need to be rebound. This project alone would cost at least \$6,000.00.

In previous reports, attention has been drawn to the cramped quarters and overcrowded condition of this office. However, during the past fiscal year, great strides have been made toward the alleviation of this condition. All of the records of the office have been placed on microfilm, which not only will protect and preserve the records in case of disaster, but also will release necessary space when microfilm is substituted for bulky volumes of the older and least used records.

However, it should be borne in mind, that no record office such as this one can ever be completely converted to microfilm and still give adequate service to the public. Other recording

offices have found that microfilm is best suited for the consultation of the older and least referred to records.

During the present fiscal year it will be necessary to install certain costly equipment for the proper housing and inspection of our microfilm.

This past highlights again the question of adequate recording fees. Inasmuch as our recording office offers a specialized service for a particular class of our citizenry, it seems unfair that the cost of this service should be borne by the general public. It is recommended that a revision of our recording fees be effectuated with a view toward making this office financially independent of other tax revenue, both in regard to recording costs and the permanent maintenance of our records.


