Resolution Requesting that this Council recognizes the critical importance of a complete and accurate Census count in 2020 and actively encourages all residents to participate in the 2020 Census beginning on March 12, 2020, and to become involved in peer education and outreach about the Census.

WHEREAS, Article I, Section 2 of the United States Constitution requires that the Census be conducted every ten years to count the population; and

WHEREAS, Households will be invited to complete the 2020 Census questionnaire beginning on March 12, 2020; and

WHEREAS, An incomplete count of Rhode Island's population in the 2020 Census will likely result in the loss of a congressional seat in the United States House of Representatives, which would leave the State with only one congressional delegate for the first time since 1789; and

WHEREAS, Population data collected during the 2020 Census will help determine the allocation of more than \$680 billion dollars in federal funds among the states each year for the next ten years; and

WHEREAS, Rhode Island receives approximately \$3.8 billion in federal funds each year, comprising more than one-third of the State's annual budget; and

WHEREAS, These federal dollars represent funding for education, health care, transportation, public safety, small businesses, housing, clean water, waste disposal and other community programs and services; and

WHEREAS, Local jurisdictions across Rhode Island use Census data to make decisions concerning the need for infrastructure projects, economic development programs, job training, health care services, and other community resources; and

WHEREAS, A lack of public awareness about the purpose of the Census and its importance for our communities, exacerbated by widespread misinformation about the Census, may result in a disproportionate undercount of historically marginalized communities, particularly among immigrants and individuals with limited English proficiency; and

WHEREAS, For the first time in United States history the Census will be conducted primarily online, creating potential barriers for communities with limited internet access; and

WHEREAS, One-quarter of Rhode Island's population lives in "hard-to-count" Census tracts, where obtaining a fair and accurate count has historically proven to be difficult, including such communities as Woonsocket, Central Falls, Pawtucket, Providence, West Warwick, South Kingstown, and Newport; and

WHEREAS, It will require the united action of all of Rhode Island's cities and towns to ensure a complete and accurate count in the State and, furthermore, it will be vitally important for city and town governments to be active in supporting local census outreach and education efforts through a variety of means, including presentations, websites, electronic newsletters, social media posts, and mailings.

NOW, THEREFORE, BE IT RESOLVED, That this Council recognizes the critical importance of a complete and accurate Census count in 2020 and actively encourages all residents to participate in the 2020 Census beginning on March 12, 2020, and to become involved in peer education and outreach about the Census; and

BE IT FURTHER RESOLVED, That every council member will promote participation in the Census by signing up for the pledge tool by texting Pledge to (401) 205.3434; that every council member will consider other ways to promote Census participation, including integrating messages into regular constituent communications, and that every council member will help increase the count in their respective wards using the resources and materials developed by the Rhode Island Complete Count Committee in their Census promotion efforts.

Resolution Endorsing and Urging Passage of by the General Assembly of Senate Bill S-
2513 and House Bill 2020 H-7611, Act Relating to Health and Safety - Beverage
Container Deposit Recycling Act of 2020.

WHEREAS, The State of Rhode Island does not currently have a bottle return program
and therefore relies entirely on curbside recycling programs to collect and transport all recyclable
beverage containers to the Rhode Island Resource Recovery Center (RIRRC); and

WHEREAS, The State of Rhode Island does not have a process to recycle glass products
of any kind as it has been deemed cost prohibitive to do so; and

WHEREAS, Recyclable bottles that are not collected through curbside recycling
programs end up in the environment, including our waterways, where it can take hundreds, and
in some cases thousands, of years for the bottles to biodegrade; and

WHEREAS, The RIRRC has the authority to reject trucks attempting to deposit curbside
recycling, if it is determined that the load is comprised of more than 10% non-recyclables or
trash, and force the entire shipment to be rerouted to the Johnston landfill for processing as trash;
and

WHEREAS, The City of Providence spends nearly half a million dollars annually as a
result of rejected cycling loads by the RIRRC and the associated costs of rerouting and
processing shipments at the Johnston landfill; and

WHEREAS, The Johnston landfill is rapidly reaching capacity, with an anticipated
closing date of 2038, and forcing recyclable materials to be stored in the landfill will only
worsen the problem; and

WHEREAS, A bottle return program would increase the collection rate of beverage
containers by creating an additional, incentivized, method for recycling separate from existing
curbside recycling programs; and

WHEREAS, The use of redemption centers for collecting recyclable beverage containers
would eliminate the potential for contamination that comes with curbside recycling, thereby
reducing the risk of recyclable beverage containers ending up in the environment or in the
Johnston landfill; and

WHEREAS, Senate Bill S-2513 and H-7611, the Beverage Container Deposit Recycling Act of 2020, provide an avenue for Rhode Island to move toward a bottle return program that will reduce the need for curbside recycling, improve the quality of our environmental, and strengthen the fiscal health of both the City and the State.

NOW, THEREFORE, BE IT RESOLVED, That the Members of the Providence City Council hereby endorse and urge passage by the General Assembly of Senate Bill S-2513 and House Bill 2020 H-7611, Acts Relating to Health and Safety - Beverage Container Deposit Recycling Act of 2020.

BE IT FURTHER RESOLVED, The City Council encourages the General Assembly and the Rhode Island Resource Recovery Center to establish a mechanism for recycling glass products within the state.

Resolution Requesting annual production and submission to the Council of a five-year plan outlining the maintenance and replacement schedules for all public safety vehicles.

WHEREAS, The Commissioner of Public Safety and the Department of Public Property are responsible for maintaining and replacing the City of Providence's public safety vehicles; and

WHEREAS, Over one third of the City of Providence's fire trucks are twenty years of age or older; and

WHEREAS, The National Fire Protection Association has established the national standard for maintenance and replacement of fire engines and ladder trucks at no more than fifteen years as a front line vehicle, with an additional five years as a reserve, prior to final replacement; and

WHEREAS, The Commissioner of Public Safety and the Department of Public Property have failed to provide adequate maintenance and replacement schedules for the City's Public Safety Vehicles; and

WHEREAS, By failing to maintain adequate replacement schedules in conformity with national standards, the Commissioner of Public Safety and the Department of Public Property are creating an unnecessary safety risk for the public as well as to the city personnel who have to operate the vehicles.

NOW, THEREFORE, BE IT RESOLVED, That the City Council hereby request that the Administration provide the City Council with a five-year plan that is produced and submitted annually on or before January 31 of each calendar year.

BE IT FURTHER RESOLVED, That said five-year plan shall include condition assessments, maintenance records, replacement schedules, and a completed inventory of all public safety vehicles, provided that all replacement schedules shall conform to minimum national industry standards.

BE IT FURTHER RESOLVED, That, upon passage, copies of this resolution be sent to the Mayor of Providence, the Commissioner of Public Safety, and the Director of Public Property.

COUNCILMAN SALVATORE, COUNCILMAN ESPINAL

Resolution Establishing a Special Commission on Recycling.

WHEREAS, Recycling materials removed from the City of Providence are shipped to the Rhode Island Resource Recovery Corporation (RIRRC) recycling facility in Johnston; and

WHEREAS, RIRRC has the authority to reject a recycling shipment in the event that non-recyclables comprise more than 10% the total shipment; and

WHEREAS, In the event a shipment is deemed to be a "contaminated load" by RIRRC, the City of Providence is charged either a \$250 processing fee, or \$47/ton if the driver "self-rejects", and the entire shipment is sent for processing at the landfill; and

WHEREAS, Rejected loads count towards total tonnage the City is allowed to deliver to the landfill each year; and

WHEREAS, In the event the City goes beyond its allotted cap it is charged \$80/ton for all deliveries beyond the cap; and

WHEREAS, In 2019 the City was forced to pay \$476,000 as a result of rejected recycling loads.

NOW, THEREFORE, BE IT RESOLVED, That the City Council of the City of Providence does hereby establish a Special Commission on Recycling, the purpose of which shall be to study and make recommendations regarding the current recycling process within the City, and to make recommendations regarding appropriate changes to City procedures, State law, and programs aimed at educating the public on proper recycling strategies.

BE IT FURTHER RESOLVED, That the Special Commission on Recycling shall: 1) consist of not more than seven members including the Director of Public Works, one member appointed by the Mayor, and five members to be appointed by the Council President; and 2) shall issue a report of recommendations to the City Council within 120 days of the date appointments are made to the commission.
