RE: PENDING MATTER

REQUEST: That the Traffic Engineer is requested to redirect traffic along Manton Avenue and Atwells Avenue.

DISPOSITION: The installation of a Traffic Signal System with median islands is warranted. However, this department does not have the funds available at this time. Monies from the Councilperson's Bond allotment could be used. The cost of design and construction would be well over \$80,000.
