
NOW, THEREFORE, BE IT RESOLVED, That the Members of the Providence City Council hereby endorse House Bill 86-H 7853.



RELATING TO BOXING ON SUNDAYS

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 41-5-2 of the General Laws in Chapter 41-5  
2 entitled "Sports, Racing and Athletics" is hereby amended to read as  
3 follows:

4 41-5-2. Sunday boxing prohibited. -- In no case shall any No  
5 boxing or sparring match or exhibition, whether or not exempted under  
6 section 41-5-1, shall occur on Sunday; provided, however, that, in  
7 the year 1986, the commission may, upon application, permit one boxing  
8 or sparring match or exhibition to take place on Sunday.

9 SECTION 2. This act shall take effect upon passage.
