AN ORDINANCE

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF PROVIDENCE:

SECTION 1. To defray the expenses of the City of Providence for the fiscal year ending June 30, 1994, the sums of money or so much thereof, as are authorized by law, indicated in the accompanying schedule, are hereby appropriated for the objects and purposes, and in amounts expressed therein provided that payments thereunder shall be subject to the provisions of the Home Rule charter of 1980, validated by the General Assembly of the State of Rhode Island at its January Session, A. D., 1981, and approved November 4, 1980, and subject to the provisions of the City Ordinances relative to the expenditures of money from the City Treasury. Fiscal Assistance to State and Local Government rules and regulations shall govern the portion of this Budget so designated.

SECTION 2. The payments to the School Fund of the following estimated receipts included in the appropriation of \$132,259,872 for the support of Public Schools for the City of Providence fiscal period 1993-1994, will be increased or decreased to conform with the actual amounts received from such sources during the City of Providence fiscal year 1993-1994.

SECTION 3. Any transfer to the General Fund from Expendable Trust Funds shall be restricted to and deemed to be utilized for the payment of debt obligations of the City of Providence.

~~1. No temporary employee shall be granted permanent status.~~

~~2. No temporary or permanent position shall be filled.~~

~~Unless approved by the City Council Committee on Finance.~~

~~WHEREAS, The Supreme Court of Rhode Island has ruled that the governing body of a municipality may limit the authority of its negotiators with respect to collective bargaining agreements with labor organizations, and~~

~~WHEREAS, The Superior Court has held that the Providence City Council may lawfully limit the authority of the Mayor of the City of Providence by issuing instructions with respect to labor negotiations, and~~

~~WHEREAS, The cost of employee benefits has a direct and significant impact on the finances of the City of Providence, and~~

~~WHEREAS, The Providence City Council has issued such instructions to the Mayor in the past in furtherance of its appropriation authority~~

~~NOW, THEREFORE, BE IT ORDAINED, That neither the Mayor nor any other individual acting as negotiating agent on behalf of the City of Providence shall have the authority to enter into a collective bargaining agreement on behalf of the City of Providence with any labor organization unless such agreement~~

~~includes all of the following:~~

- ~~1. Elimination of health benefits for life for new employees;~~
- ~~2. New Employees shall be required to make a contribution or co-payment for their health insurance coverage;~~
- ~~3. The term of the contract shall not exceed one year;~~
- ~~4. Lay-offs shall not be prohibited;~~
- ~~5. Wage increases should not exceed 4.68 percent;~~

~~Any collective bargaining agreement entered into on or after the date hereof shall not be effective, binding upon or enforceable against the City of Providence unless the agreement incorporates the provisions required hereunder.~~

~~The limitations contained herein shall remain in affect and until this Ordinance is modified, repealed or suspended.~~

SECTION 7. The provisions included in this ordinance supercede any prior ordinances or any provisions thereof.

SECTION 8. This ordinance shall take effect upon its passage.

SECTION 4. Due to the large dollar value of uncertainties in the proposed 1993 - 1994 budget, it is hereby ordained that there shall be a hiring freeze for all positions funded by this appropriation ordinance including School Department positions. A hiring freeze shall be defined as :

1. No temporary employee shall be granted permanent status.
2. No temporary or permanent position shall be filled.

Unless approved by the City Council Committee on Finance.

SECTION 5. Funds listed under the appropriation line item City Council Education Fund can only be spent for the following School Programs:

The Feinstein School  
The Urban Collaborative  
The Reality Therapy Program  
Providence Public Library \$200,000

SECTION 6.

WHEREAS, The Supreme Court of Rhode Island has ruled that the governing body of a municipality may limit the authority of its negotiators with respect to collective bargaining agreements with labor organizations, and

WHEREAS, The Superior Court has held that the Providence City Council may lawfully limit the authority of the Mayor of the City of Providence by issuing instructions with respect to labor negotiations, and

WHEREAS, The cost of employee benefits has a direct and significant impact on the finances of the City of Providence, and

WHEREAS, The Providence City Council has issued such instructions to the Mayor in the past in furtherance of its appropriation authority

NOW, THEREFORE, BE IT ORDAINED, That neither the Mayor nor any other individual acting as negotiating agent on behalf of the City of Providence shall have the authority to enter into a collective bargaining agreement on behalf of the City of Providence with any labor organization unless such agreement

includes all of the following:

1. Elimination of health benefits for life for new employees;
2. New Employees shall be required to make a contribution or co-payment for their health insurance coverage;
3. The term of the contract shall not exceed one year;
4. Lay-offs shall not be prohibited;
5. Wage increases should not exceed 4.68 percent;

Any collective bargaining agreement entered into on or after the date hereof shall not be effective, binding upon or enforceable against the City of Providence unless the agreement incorporates the provisions required hereunder.

The limitations contained herein shall remain in affect and until this Ordinance is modified, repealed or suspended.

SECTION 7. The provisions included in this ordinance supercede any prior ordinances or any provisions thereof.

SECTION 8. This ordinance shall take effect upon its passage.

Dear Mr. Clement:

Pursuant to Sections 302(f) and 412 of the Providence Home Rule Charter of 1980, I hereby disapprove and veto Section 4 and Section 6 of **An Ordinance Making an Appropriation of Two Hundred Ninety-One Million, Three Hundred Seventy-Five Thousand, Eleven Dollars (\$291,375,011) for the fiscal year ending June 30, 1994, as amended.**

### SECTION 4

I have vetoed Section 4 which seeks by its terms to ordain a hiring freeze because the City Council, by ordaining such a provision, is acting in excess of its powers under the Providence Home Rule Charter of 1980 ("City Charter"). Such an action by the City Council is a nugatory attempt to restrict the executive and administrative powers vested in the Mayor and the several department heads, boards, agencies and commissions under the City Charter. Further, such a hiring freeze would significantly impair public safety, public education and other vital city services mandated by the City Charter and state law.


