# RESOLUTION OF THE CITY COUNCIL

## RESOLVED, DECREED & ORDERED

That the following named street shown as cross-hatched area on the accompanying plan entitled "Providence Plan, Rhode Island Department of Public Works-Engineering Office, street line section Plan No. 064618 dated February 2, 1999.

Viz: Aleppo Street, that portion shown as a cross-hatched area on accompanying plan and designated by the letters (A-B-C-D-A), having ceased to be useful to the public and is proposed to be abandoned as a public highway, said abandonment is specifically conditioned precedent upon the following:

1. Petitioner shall tender the amount of Two Thousand Nine Hundred Thirty Dollars and 00/100 Cents (\$2,930.00) in legal tender U.S. currency to the City of Providence.

2. The City shall retain a full sewer easement which will permit retention of its facilities in their existing location, together with the right to inspect, maintain, operate and replace the same and with twenty-four (24) hour access to said facilities or, in the alternative, should it be determined by the Petitioner that any such facilities need to be relocated in order to comply with an intended use, the Petitioner shall assume all costs of relocation.

3. The Petitioner shall convey an easement acceptable to the Narragansett Electric Company which will permit retention of its facilities in their existing location, together with the right to inspect, maintain, operate and replace the same with twenty-four (24) hour access to said facilities or, in the alternative, should it be determined by the Petitioner that any such facilities need be relocated in order to comply with an intended use, the Petitioner shall assume all costs of relocation.

4. The Petitioner shall convey an easement acceptable to Bell Atlantic which will permit retention of its facilities in their existing location, together with the right to inspect, maintain, operate and replace the same and with twenty-four (24) hour access to said facilities or, in the alternative, should it be determined by

The Petitioner shall convey an easement acceptable to the Narragansett Bay Commission which will permit retention of its facilities in their existing location, together with the right to inspect, maintain, operate and replace the same with twenty-four (24) hour access to said facilities or, in the alternative, should it be determined by the Petitioner that any such facilities need be relocated in order to comply with an intended use, the Petitioner shall assume all costs of relocation.



Dear Councilman Clarkin:

The City Plan Commission at its regular meeting on Thursday September 24, 1998, reviewed and evaluated the request from the Committee on Public Works for the proposed abandonment of Aleppo Street. The petitioner is Thomas G. DeConcilis, Jr. and owner of adjacent lots 522 and 325 on Assessor's Plat 63.

Aleppo Street is a paper street the runs from Sheridan to Bosworth and is the site of the proposed Northwest Bikepath to be developed by RIDOT. Mr. DeConcilis, is owner of the Curtis Arms Apartments, a 106 unit apartment building for the elderly and disabled. Lot 325, which is vacant land and is owned by the petitioner is on the other side of Aleppo Street. A portion of Lot 325 is to be sold to the Land for Public Trust as part of the proposed Woonasquatucket River Greenway Project.

The petitioner would like to take possession of both sides of the street in order to construct a new parking lot and create some outdoor recreation (horseshoe court, bocce court and shuffle board court) for Curtis Arms residents. The new parking, about 40 to 50 more spaces will be attached to the existing parking for the Curtis Arms Apartments property. The petitioner intends to add fencing, security, lighting and an automatic gate to the new parking area.

At this time the petitioner and The Trust for Public Land are finalizing negotiations to retain about forty feet of land for Curtis Arms. The Trust has commissioned a survey to identify the perimeters of lot 325, to flag wetlands and locate the paper street and to locate the building on lot 522. With this survey, a plan to address the petitioner's needs while insuring room for the development of the bikepath and Greenway Project, will be developed.

The Commission has reviewed and evaluated the request for consistency with the City's Comprehensive Plan. The Commission found the proposed abandonment is consistent with *Providence 2000: The Comprehensive Plan*.

The Commission would advise the Committee on Public Works to approve the proposed abandonment, subject to the future compromise with the Trust for Public Land and Mr. DeConcilis. Therefore, the City Plan Commission voted to recommend that the City Council approve the abandonment of a portion of Allepo Street subject to a suitable compromise between the petitioner and the Trust for Public Land.







The Petitioner shall convey an easement acceptable to the Narragansett Electric Company which will permit retention of its facilities in their existing location, together with the right to inspect, maintain, operate and replace the same with twenty-four (24) hour access to said facilities or, in the alternative, should it be determined by the Petitioner that any such facilities need be relocated in order to comply with an intended use, the Petitioner shall assume all costs of relocation.

4. The Petitioner shall convey an easement acceptable to Bell Atlantic which will permit retention of its facilities in their existing location, together with the right to inspect, maintain, operate and replace the same and with twenty-four (24) hour access to said facilities or, in the alternative, should it be determined by

the Petitioner that any such facilities need be relocated in order to comply with an intended use, the Petitioner shall assume all costs of relocation.

5. The Petitioner shall convey an easement acceptable to the Narragansett Bay Commission which will permit retention of its facilities in their existing location, together with the right to inspect, maintain, operate and replace the same with twenty-four (24) hour access to said facilities or, in the alternative, should it be determined by the Petitioner that any such facilities need be relocated in order to comply with an intended use, the Petitioner shall assume all costs of relocation.


6. The Petitioner and the Trust for Public Land finalize negotiations as delineated in the Communication of the City Council Committee on Public Works from the City Plan Commission and dated October 15, 1998.

ORDERED, That the Traffic Engineer be and he is hereby directed to cause a sign to be placed on the above-named highway abandoned as aforesaid, having thereon the words, "Not a Public Highway," and it is further

ORDERED, That after the entry of this order or decree, the City Clerk shall cause a notice thereof to be published in a newspaper, published in the County of Providence, at least once a week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named highway which has been abandoned, who is known to reside within the State.


