

RESOLUTION OF THE CITY COUNCIL

No. 270

Approved April 24, 1986

RESOLVED, DECREED AND ORDERED, That the created Right-of-Way from Nolan Street to Smith Street, be received as a Public Highway and to be named at a later date under the provisions of Chapter 987, Public Laws 1913.

Beginning at a point on the northerly street line of Smith Street in the City of Providence, Rhode Island, said point being located four hundred sixty four and 18/100 (464.18') feet westerly from the intersection of the northerly street line of Smith Street with the westerly street line of Candace Street, said point also being the most southeasterly corner of the parcel herein described;

thence northwesterly along the northerly street line of Smith Street a distance of fifty (50') feet to a point, said point being the most southwesterly corner of the parcel herein described;

thence turning an interior angle of ninety (90°) degrees and travelling northeasterly a distance of one hundred eighteen and 11/100 (118.11") feet to a point on the southerly street line of Nolan Street, said point being the most northwesterly corner of the parcel herein described;



thence turning an interior angle of eighty nine degrees, fifty nine minutes, eighteen seconds (89°-59'-18") and travelling a distance of fifty (50') feet northeasterly along the southerly street line of Nolan Street to a point, said point being the most northeasterly corner of the parcel herein described


thence turning an interior angle of ninety degrees, zero minutes, forty two seconds (90°-00'-42") and travelling southwesterly a distance of one hundred eighteen and 10/100 (118.10') feet to the point and place of beginning.

The last described course forms an angle of ninety (90°) degrees with the first course described herein and contains five thousand nine hundred five (5,905±) more or less square feet of land.
