COUNCILMAN ALLEN requests the Privilege of the floor to speak on a point of personal expression and states:

"Madam President and Members of this Honorable Body, on November 3, 1992 it was an Election Year and on that day, 18,926 voters said "Yes" to the issue of Residency in the City of Providence.

That vote meant that any new employee of the City of Providence would be a resident of the City of Providence within six months.

On November 13, 1994, the Providence Journal featured an article about Patrolman Richard Ruggiero, Jr. and in that article it states that Mr. Ruggiero was 26 year of age and lives in the Town of Johnston.

Now, I went to the Personnel Department of the City of Providence and Mr. Ruggiero was hired on May 13, 1994, which meant that he should have been a resident of the City of Providence by November 13, 1994.

Our Home Rule Charter Section 903 (p) which says "It shall be the duty of the director of personnel to monitor on a timely basis the residency requirements"

Madam President, that has not been done and that has not been done in Mr. Ruggerio's case.

About a year ago there was another Police Officer who was hired under the Residency Requirement and who was living in Narragansett.

I think that what needs to be done is that the

issue of Residency to be taken more seriously. So, these are at least two instances and at the next Council meeting both myself and Councilman Jackson will be introducing an Ordinance to establish a Residency Commission for the City of Providence. I think that this is the only way that this City will become in a true sense, what was the intent of those 18,926 voters back at the Election in 1992 and the 15 Members of this City Council. Thank you Madam President."
