
Dear Mayor Paolino:

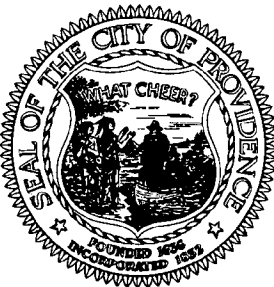
