RESOLUTION OF THE CITY COUNCIL

No. 345

Approved June 2, 1961

Whereas, and in accordance with the provisions of Section 8 of Article III of Chapter 121 of the 1960 Public Laws, Mayor Walter H. Reynolds and Traffic Engineer Roger T. Chandler have filed with the City Council a report of a proposed off-street parking facility at the area bordering on Fountain, Eddy and Worcester Streets in the City of Providence, which report includes an estimate of the cost for the necessary property acquisition and of the income yield and capacity of the facility, and states that the facility conforms with the general plan and also with the Downtown Providence Master Plan as developed by the City Plan Commission in collaboration with the Traffic Engineer.

NOW, THEREFORE, BE IT RESOLVED, That the City Council of the City of Providence hereby judges and determines that public necessity requires the establishment of an off-street parking facility in the area bounded by Fountain, Eddy and Worcester Streets, and further designated as Lot 145 on Assessor's Plat 25, and that a total sum of THREE HUNDRED FIVE THOUSAND (\$305,000) DOLLARS will be required for the acquisition of said area.

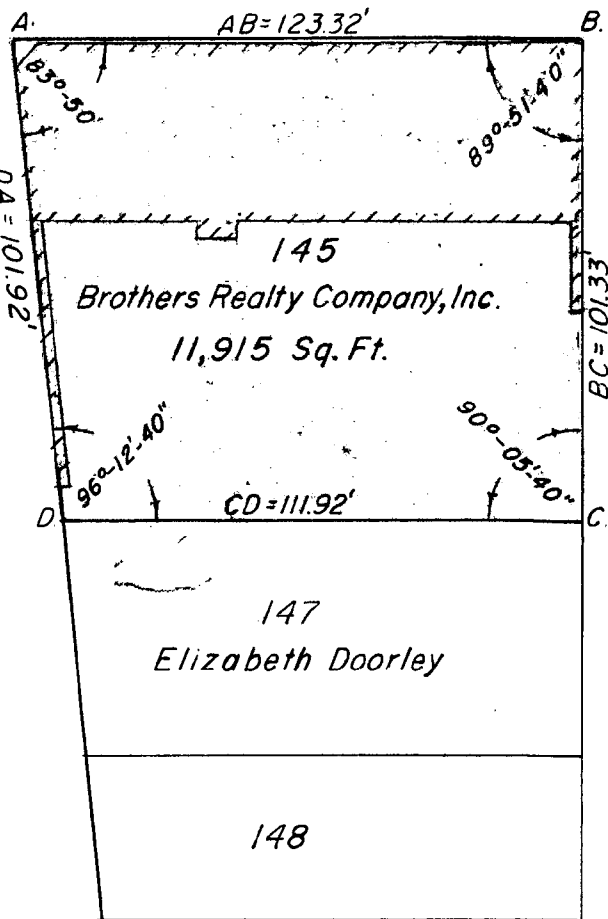

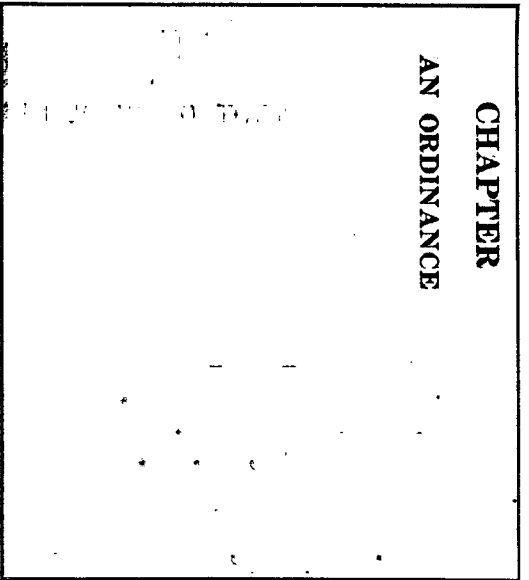

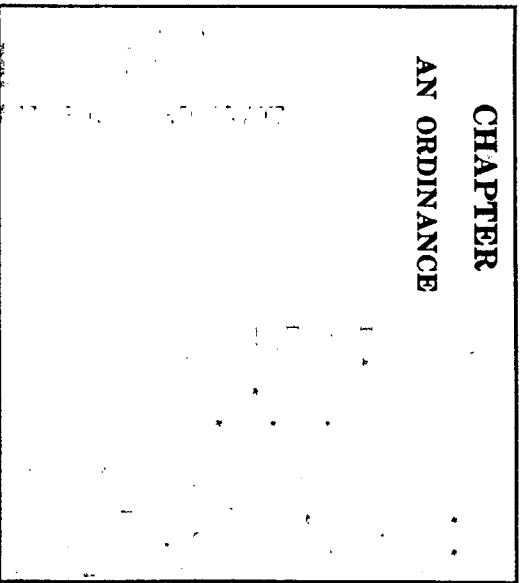
