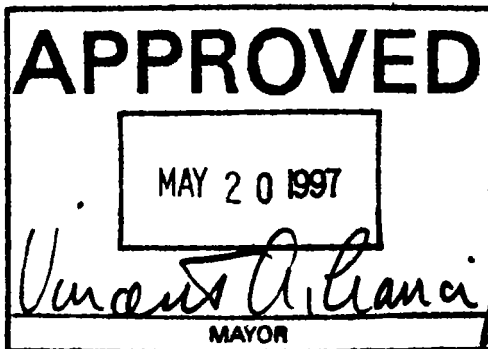

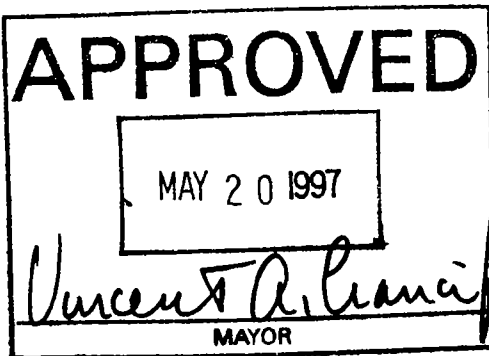

① I wanted to see what you could do about a couple of problems we have in our neighborhood regarding traffic control. Knight Street International Speedway is now out of control. This is the only road between Broadway and Westminster without even one stop sign. In addition, the no parking signs on the Westminster bound side are unreadable.

I would like to propose 4-way stop signs at Carpenter Street and Knight Street and Brighton Street and Knight Street. This will obviously slow down the speeders. Enclosed are pictures of the areas of concern.

② Finally, as of May 3, no street cleaner has been on Knight Street. The sand left over from the winter has created a safety hazard.




