No. 368 AN ORDINANCE AMENDING THE APPROPRIATION ORDINANCE, CHAPTER 1489, BY APPROPRIATING THE SUM OF FIVE HUNDRED (\$500.00) DOLLARS TO THE PEOPLE-to-PEOPLE of RHODE ISLAND, INC. IN CONJUNCTION WITH THE VISIT of the 1963 ALL STAR VENEZUELAN HIGH SCHOOL BASEBALL TEAM.

Approved May 17, 1963

Be it ordained by the City of Providence:

SECTION 1. Chapter 1489 of the Ordinances of the City of Providence as approved September 21, 1962, entitled: "An Ordinance Making Appropriation of \$43,334,668.75 for the Support of the City Government for the Fiscal Year Ending September 30, 1963", as amended, is hereby further amended by appropriating the sum of Five Hundred (\$500.00) Dollars to the PEOPLE-to-PEOPLE of RHODE ISLAND, INC.,

SECTION 2. The money hereby appropriated shall be paid to the Treasurer of the People-to-People of Rhode Island, Inc., in conjunction with the visit of the 1963 All Star Venezuelan High School Baseball Team, during the month of May.

SECTION 3. The said sum of Five Hundred (\$500.00 Dollars as hereby appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 4. The estimated receipts from Reserve for Extraordinary Expenditures are hereby increased by the sum of Five Hundred (\$500.00) Dollars.

SECTION 5. This ordinance shall take effect upon its passage.

WHEREAS, the public announcement of the proposed transfer of a major portion of the operations of the Brown & Sharpe Manufacturing Company has caused real concern to the employees of the Company and also to the City Administration and taxpayers of the City; and

WHEREAS, it is vital to the economic condition of the City that the plant facilities, as they become available, be immediately returned to productive occupancy and use; and

WHEREAS, the City of Providence has in its employ a man qualified to expedite the numerous electrical, plumbing, building and other various permits which will be required to rehabilitate the existing plant facilities for diversified industrial use; and

WHEREAS, this man through years of dedicated service has acquired a knowledge of the operations of other city departments which would allow him to secure their prompt cooperation;

NOW BE IT HEREBY RESOLVED, That His Honor the Mayor designate Mr. Vincent DiMase, Director of the Department of Building Inspection, as the Liaison Officer between the officials of the Capitol Industrial Center and the several departments and agencies of the City of Providence for the purpose of insuring the City's complete and immediate cooperation with the Center to encourage future industrial occupancy and use.
