

Regarding the septic system on McCellan Street, be advised that this matter has been turned over to the state DEM as they have jurisdiction in such matters. They have inspected and tested several of the privately owned cesspools on this street. They have not found it necessary to order any property owners to install a new leaching field for their cesspools. If properly maintained, cesspools may operate effectively for many years - with minimum private maintenance. At this time, the DPW is not funded to install a city owned sewer line on this street for this plat, as due to deep underground ledge, an estimated cost for such an installation is \$75 to \$100 thousand dollars. Such a job would have to be done by a private contractor, if funding was available. this budgetary matter may be considered as part of the FY 94 budget.




