### No. 115 AN ORDINANCE

IN AMENDMENT OF CHAPTER 1994-24, NO. 365 OF THE ORDINANCES OF THE CITY OF PROVIDENCE ENTITLED "THE CITY OF PROVIDENCE ZONING ORDINANCE" APPROVED JUNE 27, 1994, AS AMENDED, BY AMENDING PROVIDENCE ZONING DISTRICT MAP NUMBER 63 OF THE OFFICIAL ZONING MAP BY CHANGING THE ZONING DISTRICT DESIGNATION OF CERTAIN LOTS FROM R-M TO C-2.

*Be it ordained by the City of Providence:*

Section 1: Chapter 1994-24, No. 365 of the Ordinances of the City of Providence, entitled "The City of Providence Zoning Ordinance" approved June 27, 1994, as amended, is hereby amended by changing the zoning district designation of certain lots of the Zoning District Map 63 of the Official Zoning Maps as follows:

FROM R-M to C-2: LOTS 313, 311, 310, 298, 297, 296, 295, 346, 347, 349, 350, 433, 341, 562, ~~388~~, 339, 457, 456, 336 and 26.

Section 2: This Ordinance shall take effect upon passage.


