TO THE HONORABLE CITY COUNCIL OF THE CITY OF PROVIDENCE:


The undersigned respectfully petitions your honorable body

We seek permission to construct a platform landing and exit stairs at 97 Orange Street which is a side fire exit for the Offices of the Attorney General of the State of Rhode Island at 72 Pine Street according to the enclosed plan. A landing is required on the outside of the door according to the Rhode Island State Building Code, Section 616.3. It should be noted that while providing for a safer means of egress, the new landing platform would still leave a 48" sidewalk for pedestrian traffic.

Copies of the plan have been sent to the Department of Public Works, the Traffic Engineering Department and the Providence Department of Building Inspection for approval.

Dear Sirs:

This Department has reviewed the plan which accompanied your memorandum regarding construction of a platform landing and exit stairs at 97 Orange Street, which is the side emergency exit for the office of the Attorney General of the State of Rhode Island.


After discussing the proposal with Edward B. Wetherill, of H & S Realty, an alternate proposal was agreed upon with this office. Instead of the original proposal of a platform and stairs along the side of the building, it was agreed that it would be better to have the landing and stairs coming directly out from the building.

This office offers no objection to the alternate proposal but does recommend that the stairs comply with Sec. 616.4.1, of the R.I. State Building Code, and that they be proportioned so that the sum of 2 risers plus 1 tread, exclusive of nosing, is not less than 24 nor more than 25 inches.

A copy of the alternate proposal prepared by Mr. Wetherill and approved by the Traffic Engineering Department is enclosed herewith.

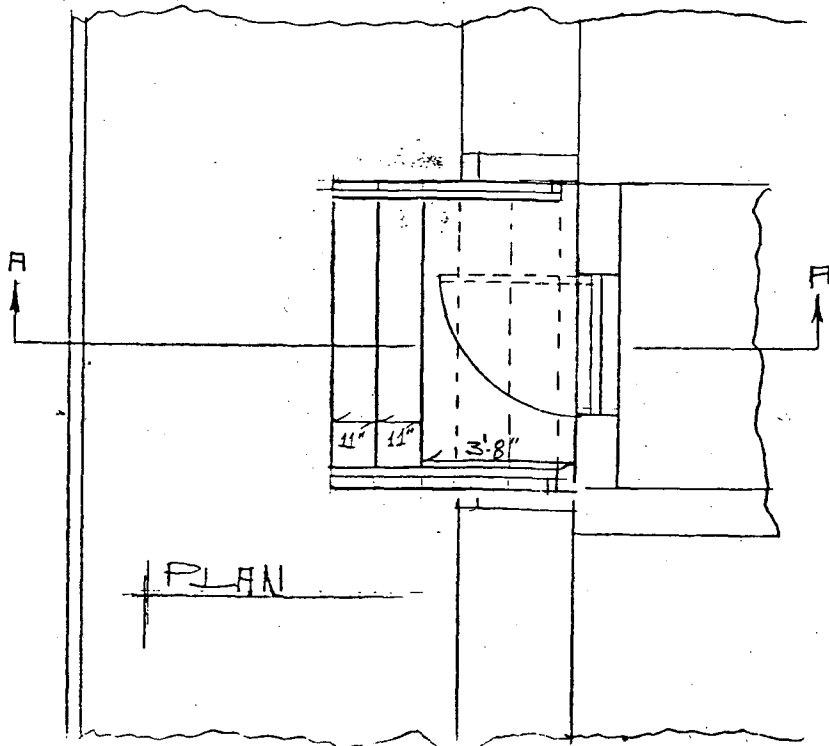
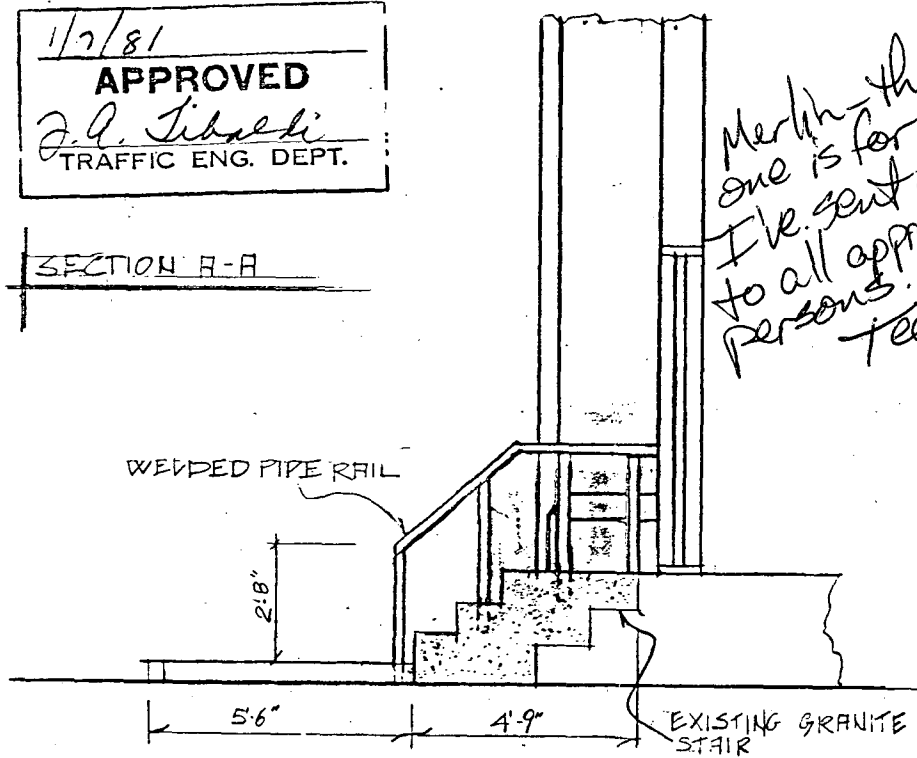

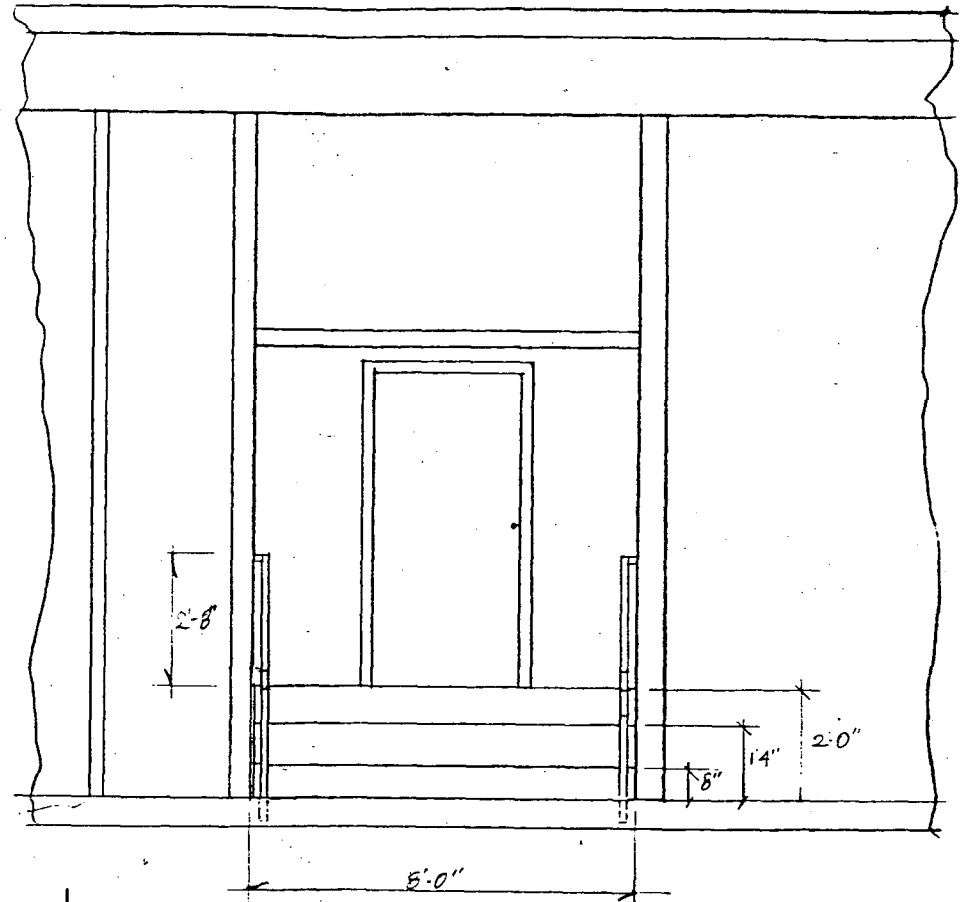
