

# RESOLUTION OF THE CITY COUNCIL

No. 405

Approved June 23, 1977

WHEREAS, Samuel Goldin, late nonagenarian resident of our Community, in passing from this life leaves a rich heritage, and

WHEREAS, Mr. Goldin, whose career as a benefactor of our Community included memorable contributions in medical and biological services, was also prominent in affairs of the Temple Beth-El, where he was recognized for his myriad of contributions in the betterment of Zionism, and

WHEREAS, as an immigrant from his native Russia, Samuel Goldin arrived in the United States of America and became a resident of the City of Providence more than One Half a Century ago,

NOW, THEREFORE, BE IT RESOLVED, that in noting the recent passing from this life of Samuel Goldin, eminent chemist and nonagenarian of our Community, the City Council pauses in its deliberation to offer its prayers for his eternal repose, and

BE IT FURTHER RESOLVED, that upon the passage of this Resolution by the City Council and its approval by the Mayor, the City Clerk is directed to transmit a duly engrossed copy thereof, to his son, Edward S. Goldin of Providence, formerly a Member of the City Council of Providence, that he and his sisters and their respective grandchildren and great grandchildren will have knowledge of the respect in which Samuel Goldin was accorded by the City Council.


Dear Lady and Gentlemen:
