Approved August 22, 1966

RESOLVED, DECREED AND ORDERED,

That the portion of East Orchard Avenue from Butler Avenue to Patterson Street shown as shaded area and designated by the letters A-B-C-D-A on the accompanying plan entitled, "Providence, R. I., P. W. Dept.-Engineering Office, Street Line Section, Plan No. 063014, Date July 25, 1966, has ceased to be useful to the public and the same is abandoned as a public highway and the damage to the abutters is appraised at nothing and so awarded, and it is further

Stipulated that the abandoned portion of East Orchard Avenue be subject to a perpetual right and easement, twenty (20) feet in width, to be granted to the City of Providence by any and all persons who may acquire ownership of the above described area by virtue of the aforesaid proposed abandonment for the purpose of maintaining, operating or rebuilding a sewer within, across, through and upon the above described premises together with the right of the City of Providence by its agents, servants, officers and employees to enter said premises at all reasonable times for the purpose of repairing, rebuilding and operating a sewer with such tools and other equipment as may be necessary and provided further that it is expressly understood and agreed that no structure shall be placed over or upon said easement or the land over or upon said easement be used so as to endanger the sewer in any way, and it is further

ORDERED, That the Director of Public Works, be and he is hereby directed to cause a sign to be placed on East Orchard Avenue from Butler Avenue to Patterson Street, abandoned as aforesaid, having thereon the words, "Not a Public Highway", and it is further

ORDERED, That after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper published in the County of Providence at least once each week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting East Orchard Avenue from Butler Avenue to Patterson Street, which has been abandoned, who is known to reside within this State.




Dear Mr. Payne:

On July 15, we received a memorandum from the Department of the City Clerk dated July 8, 1966 in which was enclosed a copy of a petition to the City Council to abandon as a public highway that portion of East Orchard Avenue between the easterly line of Butler Avenue and the westerly line of Patterson Street. A similar petition was filed on November 3, 1961 and we forwarded a letter to the Chairman of your committee recommending that the petition be denied. This letter was dated November 8, 1961. Our reason for making this request was based on the fact that the abandonment of the main in that section of East Orchard Avenue between Butler Avenue and Patterson Street would seriously affect the fire flow in the area.

In a recent discussion with the attorney representing the Lincoln School, he stated that they would be willing to pay for any main reinforcement that would be required in order to provide adequate fire flow in this section even with the removal of the main in East Orchard Avenue. This would require the replacement of the existing 6" main in Patterson Street between Angell Street and East Orchard Avenue with an 8" main. The cost of this removal and replacement would be \$3,750. They would also be expected to pay for the depreciated value of the present main in East Orchard Avenue between Butler Avenue and Patterson Street which amounts to \$1,657.60. This was shown in our letter of November 8, 1961.

This means the total cost to the Lincoln School will be \$5,407.60 and we are filing a bill in the City Collector's Office against the Lincoln School in the above amount. We respectfully request that your Committee postpone final action on this matter until the department is compensated by the Lincoln School in the above amount.







RESOLVED,

THAT permission be and hereby is granted to Brown University in Providence in the State of Rhode Island, and Providence Plantations, a corporation created and existing under the laws of the State of Rhode Island, to construct, install and maintain underground conduits to be used for the purpose of conveying hot water and electric lines under and/or across the following streets:

- Lloyd Avenue.....east of Hope Street
- Hope Street.....At Bowen Street
- Bowen Street.....Hope Street to Brook Street
- Brook Street.....Bowen Street to Meeting Street
- Meeting Street.....Brook Street to Brown Street
- Thayer Street.....Meeting Street to Charlesfield St.
- Waterman Street.....Thayer Street to Brown Street

in the City of Providence, all in accordance with the accompanying plan attached hereto, entitled Drawing E-3094 - prepared by Paul L. Geiringer & Associates of New York, as approved by the City Engineer of the City of Providence, and the Public Service Engineer, and in accordance with the provisions of "An Act Authorizing the City of Providence to permit the Owner or Owners of Estates Situated upon Opposite Sides of a Street or highway to Build and Maintain a Subway, Conduit or Pipe under or across Such Street or Highway," being Chapter 1418 of the Public Laws, approved April 4, 1916, and also Ch. 1607 P.L. 1908.

The permission hereby granted is upon the condition that said underground conduits shall be so constructed as not to interfere with the use of said Lloyd Avenue, Hope Street, Bowen Street, Brook Street, Meeting Street, Thayer Street and Waterman Street, by the public or by any person or corporation having the right to maintain pipes or conduits under or in said streets; and it is further provided that the permission hereby granted is upon the condition that said underground conduits for electric and hot water lines shall be constructed under the supervision and control, and to the satisfaction

of the Director of Public Works, and upon the condition that said underground conduits shall be removed upon 90 (ninety) days previous notice from the City Council whenever in the opinion of the City Council the public interest may require the removal of the same or any part thereof; and upon the condition that in case the City of Providence shall at any time hereafter be authorized to assess owners for the private use and occupation of the public highway, the passage of this Resolution shall not in any manner affect the right of the City to charge and collect rent for the use of said Streets by said Brown University, its successors and assigns, or for maintaining thereunder said underground conduits for electric and hot water lines; and upon condition that Brown University, its successors and assigns, shall hold and keep said City of Providence harmless, safe and indemnified from and against all loss, cost, damage, payment and expense on account of any injuries to persons, or damage to property, for which said City may become liable on account of the construction, maintenance, use or repair, or neglect to properly maintain or repair, or any defect of said underground conduits for electric and hot water lines in, under and/or across said Streets, unless the wrongful act or negligence of said City, its officers or employees, shall cause such injury or damage as mentioned aforesaid; and upon condition said Brown University, its successors and assigns before commencing the work of constructing said conduits file a bond in the sum of Five Thousand Dollars (\$5,000) in form satisfactory to the City Solicitor to hold and keep said City harmless, safe and indemnified as aforesaid; and it is agreed by the acceptance hereof that the amount of said Bond shall not be construed or held to limit Brown University's general obligation to hold and keep said City harmless, safe and indemnified as aforesaid; and upon the condition that said Brown University, its successors and assigns, shall repair and keep in repair so much of said Streets, and the sidewalks of said Streets over said underground conduits as shall be required by the Director of Public Works and to his satisfaction; and also upon the condition that said Brown University, its successors and assigns, shall before commencing the construction of said underground conduits, file, ^{PROVINCIAL} with the City, Clerk a written acceptance of the terms and conditions of this Resolution, and an agreement to perform and observe all of its said terms and conditions.






