TOWN OF WESTERLY

STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS

To those Officials, Councils, Gentlemen Squires, Good Men and any other persons whatever to whom the following touches or appertains, in this Town, Country, State and Nation, and the Nations of the World.

KNOW YE: That in the Year of Our Lord One Thousand Six Hundred Sixty and Nine on May the 4th the General Assembly of the Colony of Rhode Island and Providence Plantations granted a Charter for Westerly.

That on May the 14th of said year, Westerly was incorporated, the fifth oldest town within the bounds of the Rhode Island Colony.

That this Town has persisted without interruption to the present day.

That the Year of Our Lord One Thousand Nine Hundred Sixty and Nine will mark the THREE HUNDREDTH ANNIVERSARY of the Town of Westerly, which should be appropriately recognized and celebrated.

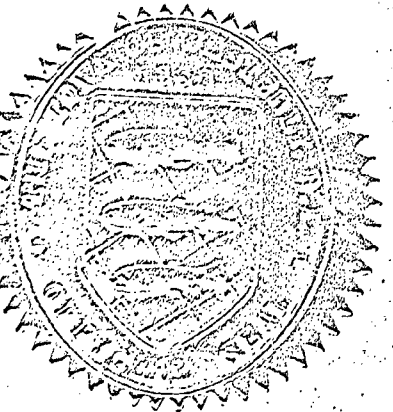
