Welcome to the Providence Fire Department:

The Providence Fire Department is the second oldest continuously operating professional fire department in the country. The Department is a full-service fire and emergency medical service agency that provides basic and advanced life support, fire prevention, fire suppression, technical rescue, and hazardous material response. In addition, the Department conducts arson investigations and building plan reviews, enforces state and local fire and life safety codes, and administers public fire education programs.

In 2022, the Providence Fire Department consisted of 7 Advanced Life Support Rescue Companies, 12 Engine Companies, 7 Ladder Companies, and 1 Special Hazard Unit, all strategically located in Providence neighborhoods. The Department is equipped to respond to all fire, medical emergency, natural disaster, hazmat, and terroristic events that occur within Providence and its surrounding communities.

On behalf of the Providence Fire Department, I present to you the Department's 2022 Annual Report that highlights the Department's many accomplishments, fire and emergency medical calls for service, training, and fire prevention activities. The Covid pandemic presented many challenges to all first responders, but we have prevailed as all our brothers and sisters have and this report is a testament to the men and women who proudly serve as Providence Firefighters.

2022 Annual Report

Established in 1854 the Providence Fire Department is the second oldest continuously operating professional fire department in the country. The Department is a full-service fire and emergency medical service agency that provides basic and advanced life support, fire prevention, fire suppression, technical rescue, and hazardous material response. In addition, the Department conducts arson investigations and building plan reviews, enforces state and local fire and life safety codes, and administers public fire education programs.

Accomplishments for 2022

In 2022, the Providence Fire Department responded to 47,166 total calls for service. Of the total calls, 73.6% were emergency medical services related. The calls are composed of 26,277 advanced life support and 8,439 basic life support calls for service. In addition, the Fire Prevention Bureau's Arson Squad conducted 386 fire investigations. As always, Providence Firefighters answered calls with professionalism, compassion, and true to our mission to protect life and all property.

The following is a list of accomplishments that have been achieved through the dedication and hard work of all the members of the Providence Fire Department:

- The Department received a 2021 Assistance to Firefighter (AFG) grant in the amount of \$1,089,415 for the purchase of washers/extractors, Ambient driers, and Pro-board training NFPA 1021, 1041 & 1521 for sworn officers.
- The Department received a 2021 Assistance to Firefighter (AFG) grant in the amount of \$240,040 for the purchase of a Metromedic Ambulance.
- Completed the revision of the Department's Standard Operating Procedures, Training Bulletin's and Rules and Regulations.
- Improved interdepartmental communication and business correspondence through implementation of online form creation and submission.
- Improved fire prevention customer service through the creation of web-based scheduling for inspections.
- Continued a partnership with Lifespan simulation lab for training all department companies with the focus on pediatric patients.
- Began recruiting for the 53rd Fire Training Academy.







Arson/Fire Prevention

The principal responsibility of the Providence Fire Departments Fire Prevention Bureau is to promote fire prevention and awareness which is essential to the departments overall mission. Some of the central functions of the Bureau includes plan review, code enforcement & inspections, public education, and fire investigations. Inspectors, plan reviewers and investigators in the bureau attend certification training and are licensed as Assistant Deputy State Fire Marshals to enforce the RI Fire and Life Safety Code.

Plan Review and Construction Inspection


The Fire Prevention Bureau oversees plan reviews for new construction and renovations to ensure compliance with the RI Fire and Life Safety Codes; including fire rated construction, egress features, emergency lighting, fire alarm and sprinkler systems. Fire Prevention Bureau personnel make on-site inspections of construction projects periodically to ensure that as-built conditions echo what was approved during the plan review process.

The 2022 calendar year was an active year for construction and renovation throughout the city. Brown University was responsible for many new construction projects in the city including: two new dormitories on Brook Street, a large addition to the Churchill House Theatre. Providence College also broke ground on a new dormitory; Shanley Hall on the Eaton Street side of campus. There were several renovation projects to existing apartment buildings and private schools in the city, one being a major renovation to 206 Elmwood Avenue which will house the future Achievement First Charter School.

Residential plan reviews are conducted for installation of interconnected smoke and carbon monoxide detection systems which are required by RI Fire and Life Safety Code in most residential occupancies; including new one-family, two-family, and three-family homes built in the city.

The Fire Prevention Bureau processed over 1,200 new plan reviews this year; while also overseeing the continuation and completion of previous years projects. Commercial and residential plan intake fees collected in 2022 totaled \$1,154,244.00; an increase of 36% over the previous calendar year.

Fire and Life Safety Code Enforcement and Inspections

The RI Fire and Life Safety Codes require that certain occupancies be inspected on an annual basis. It places emphasis on the safe operation of certain occupancies including nightclubs, places of assembly, schools, and apartment buildings. The Fire Prevention Bureau conducted 216 annual inspections of public and private schools, nightclubs and apartment buildings in the city. Additionally, the Rhode Island Life Safety Code requires all one, two and three-family residential properties to be inspected for smoke and carbon monoxide detection systems prior to transfer of ownership. The Fire Prevention Bureau also performs inspections at the request of the Providence Board of Licenses to ensure that establishments licensed for operation by the City of Providence are in compliance with the RI Fire and Life Safety Codes.

The Fire Prevention Bureau receives numerous complaints every year about potentially unsafe conditions and fire code violations. Each of these complaints is followed up on by a Fire Inspector; and sometimes involves coordination with other officials from the City’s Code Enforcement Division. Mitigating complaints is crucial to preventing loss of life and property from fire damage and other hazards. Our Inspectors mitigated over 135 complaints received into the bureau in 2022 alone.

In 2022, the Fire Prevention Bureau processed 1,165 permit applications for liquor and food licenses, outdoor dining, and various special events. The Fire Prevention Bureau provided guidance for maintaining access for fire apparatus, clearance around hydrants, fire department connections, maintaining safe egress, and safety

from vehicular traffic. Our inspectors also processed 213 permits for temporary tent installations for numerous special events and establishments throughout the city.

The RI Fire Safety Code requires home sellers to obtain a certificate of compliance from the Fire Department documenting the satisfactory inspection of smoke and carbon monoxide alarms in the home. In 2022, our inspectors completed 2,193 residential smoke and carbon monoxide inspections generating \$65,785 in revenue.




Fire Investigations

Providence Fire and Arson Investigators conducted 386 cause-and-origin investigations in 2022. Of these, 230 were classified as building fires, 103 were vehicle fires, and 53 were miscellaneous fire incidents that included: electrical problems, boiler malfunctions, outside fires, and boat fires. By occupancy type, fires occurred in 76 residential 1 & 2 family homes, 110 multi-family homes, 28 high-rise occupancies, 45 commercial spaces, 10 education facilities and 4 places of assembly.

In 2022, the majority of building fires were in residential structures. Fifteen fires were in vacant structures, and 28 were in high-rise occupancies.

The Department's Arson Squad assists in the investigation of multi-alarm fires, fires of suspected incendiary origin, and fires involving injuries or death. In 2022, there were 24 civilian injuries and 5 civilian deaths caused by fires in the city.



The Arson Squad, including K9 Wizard - an accelerant detection canine, maintains a relationship with Providence Police, the State Fire Marshal's Office, local offices of the FBI and ATF, along with fire investigators in the surrounding cities and towns.

Public Education

The Providence Fire Department participated in a wide range of formal public education and outreach activities in 2022. Education was presented through daycares, high-rises, apartment buildings, private and public schools, community organizations and events. At these events, members of the Fire Prevention Bureau distributed various educational materials, coloring books, and other fire safety messages. Fire apparatus were sent to 65 Touch-A-Truck events, and our new Smoke Trailer participated in 15 events in the city. Overall, 120 separate events were held in the city which reached an estimated 9,250 members of the community. Our Fire Prevention Bureau continues to provide free smoke and carbon monoxide alarms for distribution to those in need throughout the city. In 2022, 101 smoke alarms and 41 carbon monoxide alarms were provided to residents of the City of Providence.
